# **PATROL DEPUTY REPORTS**

Past Two Weeks Reported in Chronological Order

#### Sunday, Dec. 26

I patrolled the neighborhood and completed all 44 vacation watch checks. All homes were secure. Some had packages that I placed in a more secure place. I made one telephone call on one box that was too large to leave just anywhere. The homeowner agreed to have a family member pick it up.

I responded to a 911 call. The resident had dialed by mistake.

I responded to an audible burglar alarm at one home on Kingsford. The house was vacant with contractor tools inside. I called the contact person, who said it was an ongoing problem.

#### Monday, Dec. 27

I patrolled the neighborhood and completed all 41 listed vacation watch checks. All homes were secure.

Schools were not in session today. Due to the rainy cool weather, there were not many people out and about.

I checked the river accesses, parks and numerous intersections but observed no issues.

#### Tuesday-Wednesday 10 p.m.-4 a.m., Dec. 28-29

I patrolled the neighborhood and completed all 36 listed vacation watch checks. All homes were secure.

Due to the rainy cool weather, there were not many people out and about.

I stopped a suspicious vehicle on Keane. The driver was wearing a reflective construction cover and was driving repeatedly through the neighborhood with no apparent destination. The vehicle had expired registration. I determined that the driver works for the local water district and was checking for homeowners who were over-watering their lawns.

#### Thursday Day, Dec. 30

I patrolled the neighborhood and completed all 40 listed vacation watch checks. All homes were secure.

I stopped a driver for speeding near American River and Saverien and issued a warning.

I assisted patrol in response to a report of a woman going through trash cans on Dunster. I

searched the area but was unable to locate anyone going through cans.

The rest of the shift was quiet.

#### Friday Day, Dec. 31

I patrolled the neighborhood and completed all 38 listed vacation watch checks. All homes were secure.

I received an email about suspicious subjects looking into vehicles on Wycomb Drive. I searched the area but was unable to locate the subjects.

The rest of the shift was quiet.

#### Sunday, Jan. 2

I patrolled the neighborhood and completed all 36 listed vacation watch checks. All homes were secure.

I had no calls for service and observed nothing of concern during the shift.

I spoke to a workman at a house on American River Drive that had experienced a garage break-in. He was taking further steps to secure it.

#### Monday, Jan. 3

I patrolled the neighborhood and completed all 24 listed vacation watch checks. All homes were secure.

School was still out at Rio Americano, Del Dayo and Jesuit.

I was dispatched to a residential burglary at a house undergoing remodeling in the 3900 block of American River Drive. Suspect(s) forcibly entered the garage and took new appliances awaiting installation. I took a burglary report.

#### Tuesday, Jan. 4

I patrolled the neighborhood and completed all 18 listed vacation watch checks. All homes were secure.

I monitored several stop signs for traffic violations, but observed none.



#### Tuesday-Wednesday 10 p.m.-4 a.m., Jan. 4-5

I patrolled the neighborhood and completed all 18 listed vacation watch checks. All homes were secure.

I received an email at midnight from the 4100 block of Stowe Way that described two young men stealing a package off the homeowner's porch. I was in the area and was on

scene within one minute. I saw a white male wearing black pants with white lettering on his shirt near Crondall and Claydon. I stopped him and determined that he lived in the area and had different colored shoes from those worn by the package thieves. (See image) I was unable to locate the suspects.

I found the stolen package on the sidewalk several houses away but the contents were missing. I returned the box to the homeowner, who said she did not wish to file a report. She said the contents may have been a new mop.

I stopped a driver in the Rio Americano High School parking lot. The occupants of the vehicle were two male and two female 18-year-olds. None of them matched the description of the package thieves, so I had them to leave the parking lot.

#### Wednesday Day, Jan. 5

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I responded to a 911 cell phone call from the Jesuit High School campus, but was unable to locate the caller.

I took a felony vandalism report from a resident in Selby Ranch. The victim's vehicle had two slashed tires and had been spray painted.

A resident on Exmoor Circle asked me to dispose of two of his handguns. I picked them up, gave him a receipt and booked them for destruction at the North Area Station.

Otherwise it was a quiet night.

#### Thursday Day, Jan. 6

I patrolled the neighborhood and completed all 17 listed vacation watch checks. All homes were secure.

I stopped and cited a driver for running the stop sign at Crondall and Estates.

I assisted patrol with a burglary report at Jesuit High School. The theft occurred sometime during the night of Jan. 4 or the early morning hours of Jan. 5. The thieves broke into a storage shed and removed several containers of gasoline. The incident was captured on video. The suspect vehicle was described as a dark colored Jeep with two occupants. The rest of the shift was quiet.

#### Friday Day, Jan. 7

I patrolled the neighborhood and completed all 21 listed vacation watch checks. All homes were secure except for one that had an unlocked rear door. There was nothing suspicious and I alerted the local contact about the situation.

I received an email from a WDDNA member asking what methods should be used to contact law enforcement. Crime in progress should always be reported through the Sheriff's Department dispatch line.

· Dial 911 or 916-874-5111 for emergencies.

• Non-emergency issues should be reported to 916-874-5115. If an a WDDNA deputy is working, he or she will be dispatched. If no deputy is on duty, the call will be handled by patrol.

• The <u>wilhaggin4@sachsheriff.com</u> email should ONLY be used for non-urgent concerns such as general questions, to update a vacation watch, to make deputies aware of ongoing issues to watch for or to provide additional information regarding crimes that were previously reported. It should not be used to report immediate concerns, such as suspicious activity or a crime in progress.

The rest of the shift was quiet.

#### Friday Night, 7 p.m.-3 a.m., Jan. 7-8

I patrolled the neighborhood and completed all 22 listed vacation watch checks. All homes were secure.

It was very foggy night. I checked all the river access points and all were empty. On several occasions, I had to tell groups of students to leave the Rio Americano High School grounds. They all left. All other school campuses were empty.

It was quiet otherwise.

#### Saturday, Jan. 8

I patrolled the neighborhood and completed all 22 listed vacation watch checks. All homes were secure except for one which had an unlocked rear door. This was the same home from the Jan. 7 shift. I locked the door and made sure it was secure.

I responded to a 911 hang-up from a cellphone on Claydon Way. I spoke to the resident who believed the call came from a visitor's child. The visitors had left before I arrived.

I responded to an audible alarm on Ramel Way. It had been triggered by mistake.

The rest of the shift was quiet.

#### Saturday Night, Jan. 8-9

I patrolled the neighborhood and completed all 21 listed vacation watch checks. All homes were secure.

I made sure to check all the river access points to ensure no one was loitering, including River Walk Way.

I responded to a report of a trailer parked on Regency Circle. The driver reportedly had been parking in the same spot every day since December, leaving the trailer early every morning and returning in the afternoon. I talked to the owner of the trailer, explained the county ordinance for the parking trailers on the street and put him on a verbal three-day notice.

#### Sunday, Jan. 9

I patrolled the neighborhood and completed all 25 listed vacation watch checks. All homes were secure.

On American River Drive, I met with the owner of a home that is being renovated. She had a water leak and was there handling it.

It was a quiet day.

#### Monday, Jan. 10

I patrolled the neighborhood and completed all 16 listed vacation watch checks. All homes were secure.

There were no reports of problems and the rest of the shift was quiet.

## HOW TO CALL FOR HELP

#### IN AN EMERGENCY

If you have an immediate emergency - if your life or property is in immediate danger, if you feel threatened by someone on or near your property, if you have just become the victim of a crime or if you are witnessing a crime in progress:

- CALL 911 from a land line.
- Or, if calling from a cell phone within Sacramento County, call (916) 874-5111.

#### TO REPORT A CRIME

There are two ways to report a crime to the Sacramento County Sheriff's Department:

- 1. Call the Sheriff's Department NON-EMERGENCY LINE at (916) 874-5115. To bypass the recorded messaging when you call, dial 0 after the line is answered.

#### SUSPICIOUS ACTIVITY (Not an emergency)

If you see someone engaged in suspicious activity but it is not an emergency, call 916-874-5115 (Sheriff's Department non-emergency line).
