

Twice-Monthly Patrol Report filed by WDDNA's Off-Duty Sheriff's Deputies

# PATROL DEPUTY REPORTS

Past Two Weeks Reported in Chronological Order

#### Wednesday 4-10 p.m., Jan. 10

I patrolled the neighborhood and completed all 25 scheduled vacation watch checks. All homes were secure. I was able to check on most of the homes multiple times throughout the shift.

All the river access points and schools checked clear for any suspicious activity.

#### Thursday 8 a.m.-4 p.m., Jan. 11

I patrolled the neighborhood and completed all 25 scheduled vacation watch checks. All homes were secure.

I cited one driver and issued a verbal warning to another for failing to come to a complete stop at American River Drive and Wilhaggin Drive.

I responded to a stranded motorist who was trying to push his vehicle on American River Drive near Watt Avenue. The driver, a 20-year-old male, and another person pushed the car onto the property at Selby Ranch. The young man said he had taken his sister's car without permission and was franticly trying to return it before she found out. I contacted his family because he could not produce his Arizona driver's license. They showed up and provided the needed documents.

The rest of the shift was quiet.

#### Friday 8 a.m.-4 p.m., Jan. 12

I patrolled the neighborhood and completed all 29 scheduled vacation watch checks. All homes were secure. At one house a side gate was open so I called the homeowner, who was appreciative.

Throughout the rest of my shift I drove the area and monitored several intersections, but observed no traffic violations.

## Friday-Saturday, 8 p.m.-4 a.m., Jan. 12-13

I patrolled the neighborhood and completed all 30 scheduled vacation watch checks. All homes were secure.

Traffic on American River Drive was fairly steady until about 11 p.m. I stopped a bicyclist with no front lamp. He lives in Wilhaggin and was riding home from work.

I spotted a teenage couple in the back seat of a car near American River Drive and Sand Bar Circle. They moved along after seeing my bright lights.

All in all, it was a quiet night in the neighborhood.

#### Saturday, 8 a.m. – 4 p.m., Jan. 13

I patrolled the neighborhood and completed all scheduled vacation watch checks. All homes were secure.

It rained during my shift, so pedestrian traffic was lighter than usual.

Mission Oaks Recreation & Park District left the supply room at Ashton Park's restroom unsecured. I advised them and returned to lock it.

There was a large soccer tournament at Rio Americano High School. I monitored vehicle traffic, but observed no violations.

#### Saturday, 4-10 p.m., Jan. 13

I patrolled the neighborhood and completed all 31 scheduled vacation watch checks. All homes were secure.

I read an email from a homeowner on Columbia who was concerned about a burglary at a vacant home on the block. I met with her and her husband. Another Sheriff's Department unit took the crime report. Burglars had entered the home by kicking open the front door. They discovered a vehicle in the locked garage, reattached the battery and attempted to steal the vehicle, but were unsuccessful.

NOTE: WDDNA has ordered additional patrol monitoring on Columbia.

I had to ask some people to leave Ashton Park after closing time. Otherwise, it was a quiet shift.

#### Monday 8 a.m. to 4 p.m., Jan. 15

I patrolled the neighborhood and completed all 20 scheduled vacation watch checks. All homes were secure.

I received an email about an unoccupied trailer parked on Saverien Drive near American River Drive. It was gone when I checked on it.

Traffic was light. I monitored American River and Saverien Drive, but observed no violations.

## Tuesday-Wednesday 8 p.m.-4 a.m., Jan. 16-17

I patrolled the neighborhood and completed all 17 scheduled vacation watch checks. All homes were secure.

It rained throughout the night. There were almost no cars on the roads.

I checked on all river access points and shooed away two bicyclist hanging out in the Rio Americano High School parking lot.

#### Wednesday 8 a.m.-4 p.m., Jan. 17

I patrolled the neighborhood and completed all 18 scheduled vacation watch checks. All homes were secure.

It was a very quiet shift.

#### Thursday 8 a.m.-4 p.m., Jan. 18

I patrolled the neighborhood and completed all 21 scheduled vacation watch checks. All homes were secure.

I issued verbal warnings to two drivers who rolled slowly through the stop sign at American River Drive and Harrington.

I cited one driver for failing to stop at the sign at American River Drive and Estates and gave a verbal warning to another for failing to fully stop at Estates and Wycombe.

A member reached out about a house off Ashton Drive that had a broken window. The house appeared to be under construction and the broken window was a small pane at the bottom of the door frame. It appeared to have been caused accidentally rather than intentionally. No information was available with which to contact the homeowner.

The rest of the shift was quiet.

## Friday 8 a.m.-4 p.m., Jan. 19

I patrolled the neighborhood and completed all 18 scheduled vacation watch checks. All homes were secure.

I monitored several intersections throughout the day. While doing so, a resident approached me with concerns about the no-parking zone near Whitehall and American River Drive. He said he believes it should be a no-stopping zone because it is difficult to pull out onto American River Drive when school is getting out. I advised him to reach out to the Department of Transportation with his concerns.

#### Saturday, 8 a.m. - 4 p.m., Jan. 20

I patrolled the neighborhood and completed all 22 scheduled vacation watch checks. All homes were secure.

I checked the river access points and parks. Jesuit High School hosted Rio American High School for a men's soccer game. It finished prior to the rain but the cold weather kept the attendance numbers down. There were no parking or traffic issues.

I checked homes on Columbia Court multiple times throughout my shift.

#### Saturday, 5-11 p.m., Jan. 20

I patrolled the neighborhood and completed all 22 scheduled vacation watch checks. All homes were secure.

Jesuit High School had an event, so there were a lot of cars leaving around 10 p.m. I patrolled Jacob, Saverign and American River Drive until traffic subsided.

I responded to two 911 calls by two Piccadilly Circle residents concerned about a possible road rage incident. I explained options to both callers.

#### Monday 7 a.m. to 2:30 p.m., Jan. 22

I patrolled the neighborhood and completed all 19 scheduled vacation watch checks. All homes were secure.

I responded to two burglar alarms. Both turned out to be false.

I checked all of the river access points, but all were clear of problems.

I monitored traffic at Jacob and Keane Drive and issued a citation to one driver who failed to stop.

I also monitored intersections at Saverien Drive and Ashton Drive, as well as Wilhaggin Drive and Wycombe, but observed no traffic violations.

### Wednesday, 6:45-10;45 a.m., Jan. 24

I patrolled the neighborhood and completed all 23 scheduled vacation watch checks. All homes were secure.

I responded to a resident's email about an incident over the weekend involving a couple of neighbors on Piccadilly Circle having an argument about their driving.

It rained most of the morning and traffic was light.

#### IN AN EMERGENCY

If you have an immediate emergency - if your life or property is in immediate danger, if you feel threatened by someone on or near your property, if you have just become the victim of a crime or if you are witnessing a crime in progress:

- CALL 911 from a land line.
- Or, if calling from a cell phone within Sacramento County, call (916) 874-5111.

#### TO REPORT A CRIME

There are two ways to report a crime to the Sacramento County Sheriff's Department:

- 1. Call the Sheriff's Department NON-EMERGENCY LINE at (916) 874-5115. To bypass the recorded messaging when you call, dial 0 after the line is answered.
