



Twice-Monthly Patrol Report filed by WDDNA's Off-Duty Sheriff's Deputies

## PATROL DEPUTY REPORTS

Past Two Weeks Reported in Chronological Order

### **Wednesday 4-10 p.m., Jan. 11**

I patrolled the neighborhood and completed all 15 listed vacation watch checks. All homes appeared secure.

I spoke to a few neighbors who thanked me for my service. During rush hour I spent some time at controlled intersections, but observed no traffic violations.

Overall it was a quiet night.

### **Friday 8 a.m.-4 p.m., Jan. 13**

I patrolled the neighborhood and completed all 23 listed vacation watch checks. All homes appeared secure.

I received an email from a member about a neighbor dispute, advised him that it was a civil matter and suggested possible options.

### **Sunday 8 a.m.-4 p.m., Jan. 15**

I patrolled the neighborhood and completed all 24 listed vacation watch checks. All homes appeared secure.

There was a large tree removal in progress on Arden Way near Kingsford.

I checked on a utility trailer parked on Jacob at Marlborough. There was no record of it having been stolen. I will follow up on the matter during the week.

Other than tree debris, there were no blocked roads.

### **Monday 8 a.m. to 4 p.m., Jan. 16**

I patrolled the neighborhood and completed all 18 listed vacation watch checks. All homes appeared secure.

The levee access points open today and there were lots of people coming and going checking on the river level.

### **Tuesday-Wednesday 8 p.m.-4 a.m., Jan. 17-18**

I patrolled the neighborhood and completed all 17 listed vacation watch checks. All homes appeared secure.

I responded to one email about a found wallet.

Patrol engaged in a pursuit southbound on Eastern onto Fair Oaks Boulevard. After they caught the driver, it was determined that he had thrown a firearm near the intersection. I assisted a K9 officer and located the firearm and several rounds that had been ejected from a high capacity magazine. I found them on Eastern Avenue about three blocks north of Fair Oaks Boulevard.

All the normal river access points checked clear.

**Wednesday 8 a.m.-4 p.m., Jan. 18**

I patrolled the neighborhood and completed all 17 listed vacation watch checks. All homes appeared secure.

Schools were in session, but there were no student issues. I got by all the river access points and all were empty. William Pond Park was quiet.

I was dispatched to a call about a man waving a gasoline can at traffic on Fair Oaks Boulevard near Jacob Lane. He was gone when I arrived.

**Wednesday 4-10 p.m., Jan. 18**

I patrolled the neighborhood and completed all 17 listed vacation watch checks. All homes appeared secure.

I checked the river access areas at Estates, Crondall and Harrington Way. All were clear.

I checked Ashton Park and saw no people or vehicles there.

**Thursday 8 a.m.-4 p.m., Jan. 19**

I patrolled the neighborhood and completed all 18 listed vacation watch checks. All homes appeared secure.

I issued a warning to a driver near American River Drive and Wilhaggin for a stop sign violation. Afterwards he asked for advice on how to keep his 15-year-old son from skipping school.

I issued a warning to a driver for a stop-sign violation near Arden Way and Carmelo Drive.

I stopped four drivers for not stopping at the stop sign near Jacob and Oak Vista. I cited one.

**Friday 8 a.m.-4 p.m., Jan. 20**

I patrolled the neighborhood and completed all 23 listed vacation watch checks. All homes appeared secure.

It was a very quiet shift.

**Saturday, 4-10 p.m., Jan. 21**

I patrolled the neighborhood and completed all 26 listed vacation watch checks. All homes appeared secure.

Jesuit had an event, but things were quiet.

I checked the river access points and all were clear.

I monitored the intersections at American River Drive and Jacob; Jacob and Keane, and American River Drive and Kingsford. Everyone behaved.

**Sunday 8 a.m.-4 p.m., Jan. 22**

I patrolled the neighborhood and completed all 29 listed vacation watch checks. All homes appeared secure.

The wind kicked up, which likely caused the one burglar alarm call I received. The home checked clear.

Other than dog walkers, there were few people on the streets.

There was an event at Rio Americano High School, but not much of a crowd. There were no traffic or parking issues.

**Monday 8 a.m. to 4 p.m., Jan. 23**

I patrolled the neighborhood and completed all 27 listed vacation watch checks. All homes appeared secure.

It was a very nice day. All three schools were in session, but I observed no traffic problems.

I monitored the intersection at American River Drive and Jacob Lane, but observed no traffic violations.

**Tuesday 8 a.m. to 4 p.m., Jan. 24**

I patrolled the neighborhood and completed all 27 listed vacation watch checks. All homes appeared secure.

I monitored Rio Americano High School traffic at the corner of Saverien Drive and American River Drive.

There was moderate traffic throughout the area but I did not observe any traffic violations.

There was a report of a fight at Rio Americano High School during which a female student was knocked unconscious. A regular patrol unit responded and arrested a suspect for felony assault. The victim was transported to the hospital via ambulance.

There was a major vehicle accident on Fair Oaks Boulevard at Jacob Lane. A red Toyota sedan rolled over into the yard of a home. The fire department responded for injuries. CHP handled the incident.

In the afternoon, I monitored traffic between Rio Americano High School and Del Dayo Elementary School, but observed no problems.

1. Call the Sheriff's Department NON-EMERGENCY LINE at (916) 874-5115. To bypass the recorded messaging when you call, dial 0 after the line is answered.
