# Saturday, Sept. 25

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

Around 10:30 a.m., I was near the Del Dayo Elementary School when I was waved down by an elderly couple, who told me their son had parked his vehicle in front of the school between 8:30 and 9 a.m. and that his window was smashed and items were taken.

A short time later, another woman waved me down to report that her vehicle window had also been smashed in the same area. She was parked on Shelato Way at Beard Way. Her purse with her wallet inside was stolen. The suspect also attempted to use her credit cards at local stores. There was a home on Shelato Way that had video footage of the incident. I reviewed it and found that it showed a white male adult in his 30s or 40s, average size, brown hair and facial hair wearing a black t-shirt, blue jeans and dark shoes. He could be seen walking back and forth on the sidewalk of Shelato Way, then he then drove up to the victim's vehicle in an older model, tan Toyota Camry. He quickly smashed the victim's driver side passenger window and took her purse from under the driver's seat.

After reviewing the video footage, it appeared to me that the suspect may have been watching the area. There was a soccer game going on at Del Dayo, so the streets were busy and people were away from their vehicles. I took a report for the victim.

There were several events going on in the neighborhood, so I made sure to circle around several times to the parking lots in case the suspect might strike those areas, too.

# Monday, Sept. 27

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I monitored vehicle traffic around Del Dayo Elementary School, Jesuit High School and Rio Americano High School. Traffic was very heavy. It was hard to move through the roadways. But I observed no traffic violations.

### Tuesday, Sept. 28

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure. At one home, I discovered an unlocked front door, but was informed that the owners had not yet left the house.

A member emailed photographs of a suspect in the vehicle burglaries that had taken place near Del Dayo School on Saturday, but I informed him that the suspect had been arrested on Sunday for similar crimes in another area.

I responded to a report of a porch pirate on Maucaulay Drive. The homeowner did not want to make a report because the value of the package was \$6, but he wanted deputies to be aware of the incident.

#### Tuesday-Wednesday 10 p.m.-4 a.m., Sept. 28-29

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

It was a quiet night.

# Wednesday Day, Sept. 29

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I responded to a domestic incident on Lantern Court. The boyfriend of the resident's adult daughter had threatened them with bodily harm. He had fled before I arrived. I took an extensive felony report to submit for a warrant.

# Thursday Day, Sept. 30

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I monitored traffic on Crondall near Estates. I stopped and cited a driver for running the stop sign.

I stopped a few drivers for traffic violations on American River Drive near Ashton and issued warnings.

The rest of the shift was quiet.

# Friday Night, 7 p.m.-3 a.m., Oct. 1-2

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I chased several carloads of juveniles out of the Rio Americano High School parking lot late in the evening.

I responded to a report of a late night party in the 800 block of Saverien Drive.

Late in the evening I responded to report of an occupied vehicle near Jacob Lane and Marlborough. It turned out to be a carload of juveniles who were out celebrating. One of the passengers had celebrated so much that he had vomited all over the backseat. The sober driver took them home.

I responded to a report of a family disturbance on Brompton Court. I was able to resolve

the issue.

#### Monday, Oct. 4

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I monitored school traffic at Rio American High School and Del Dayo Elementary, but observed no traffic violations

#### Tuesday, Oct. 5

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I responded to a report of a woman checking mailboxes on Cricket Court. I attempted to locate the subject without success. However, it appeared that no crime had been committed.

I located two vehicles parked in front of an empty lot on Crondall. Both were legally parked. One was in good condition and registered. The other was a junker with an expired registration. This vehicle had a history of being occupied by a homeless fwoman. She was not in the vehicle at the time. I cited the vehicle for having an expired registration.

I spoke with a jogger who reported a suspicious subject on the levy. I was unable to locate the subject.

#### Tuesday-Wednesday 10 p.m.-4 a.m., Oct. 5-6

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

It was a quiet night.

#### Thursday Day, Oct. 7

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I monitored traffic on Crondall near Estates. I issued a warning to one driver for failing to make a complete stop at the stop sign.

I stopped and cited a driver on American River Drive near Ashton for failing to stop at the sign.

I responded to a member who sent an email about an incident of identity theft.

The rest of the shift was quiet.

#### Friday Day, Oct. 8

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I took a report about an attempted burglary that occurred on Dunster Way just before midnight Thursday night, Sept. 30.

The rest of the shift was quiet.

#### Saturday, Oct. 9

I patrolled the neighborhood and completed all listed vacation watch checks. All homes

were secure.

I assisted with a response to a panic alarm at a home off Morris Way. It turned out to be a false alarm.

I responded to a report of an abandoned vehicle without plates parked on American River Drive at Jacob Lane. The vehicle had no vin number on the front windshield. The residents at the corner of American River Drive and Jacob Lane said it was their friend's vehicle. I informed them that vehicles with no plates or vin numbers are subject to being towed. I said the alternative was to move the vehicle into the driveway.

There were events at Del Dayo Elementary and Ashton Park. I checked those areas multiple times checking for any suspicious activity. I also visited the garage sales to show a security presence.

#### **IN AN EMERGENCY**

If you have an immediate emergency - if your life or property is in immediate danger, if you feel threatened by someone on or near your property, if you have just become the victim of a crime or if you are witnessing a crime in progress:

- CALL 911 from a land line.
- Or, if calling from a cell phone within Sacramento County, call (916) 874-5111.

#### TO REPORT A CRIME

There are two ways to report a crime to the Sacramento County Sheriff's Department:

- 1. Call the Sheriff's Department NON-EMERGENCY LINE at (916) 874-5115. To bypass the recorded messaging when you call, dial 0 after the line is answered.
