PATROL DEPUTY REPORTS

Past Two Weeks Reported in Chronological Order

WDDNA renewal season is underway

WDDNA membership renewal invoices for 2023 were emailed to everyone last week so members who prefer to renew early may do so.

As always, if you renew on or before Dec. 31, your dues will be just \$275, a \$25 discount.

You may renew by using the invoice or, if you prefer, you can logon to our website at https://wilhagginna.com/ and renew online. You also can renew by mail by enclosing your name and address, along with your check for \$275 made out to WDDNA, and sending it to WDDNA, P.O. Box 2273, Carmichael, CA 95609.

Monday 8 a.m. to 4 p.m., Sept. 26

I patrolled the neighborhood and completed all 23 listed vacation watch checks. All homes were secure.

The rest of the shift was quiet.

Wednesday 8 a.m.-4 p.m., Sept. 28

I patrolled the neighborhood and completed all 15 listed vacation watch checks. All homes were secure.

I responded to one burglar alarm, but it was false.

The rest of the shift was quiet.

Thursday 8 a.m.-4 p.m., Sept. 29

I patrolled the neighborhood and completed all 24 listed vacation watch checks. All homes were secure.

A resident waved me down to report seeing some teenagers at Ashton Park around 10 a.m. I confronted the teens, who told me they attended Rio Americano High School and were on a break. I contacted school administrators and they said the students were not supposed to be off campus and would be receiving detention.

The rest of the shift was quiet.

Friday 8 a.m.-4 p.m., Sept. 30

I patrolled the neighborhood and completed all 24 listed vacation watch checks. All homes were secure.

I received an email from a resident in the 500 block of Rodante Way regarding a suspicious silver Honda with two female occupants who told the resident they were on a lunch break, then drove away. I checked the area, but did not see the vehicle.

I responded to a report of a man driving a gold SUV who appeared to be casing homes in the 4900 block of Marlborough Way. I checked the area, but did not locate the vehicle.

I monitored traffic around the area schools but observed no major traffic issues.

Friday-Saturday, Midnight.-8 a.m., Sept. 30-Oct.1

I patrolled the neighborhood and completed all 21 listed vacation watch checks. All homes were secure.

I stopped a suspicious vehicle on Estates Drive. The driver turned out to be an Amazon deliveryman who was unable to locate an address.

I monitored traffic throughout the night but observed no major issues.

There were a lot of people walking and running early this morning. Many waived at me and a couple thanked me for being there.

Saturday 4-10 p.m., Oct. 1

I patrolled the neighborhood and completed all 22 listed vacation watch checks. All homes were secure.

I spoke to several people walking the neighborhood tonight during my checks.

There was a large block party on Southwick, so I drove by several times on Ashton, the cross street, to provide security.

Monday 8 a.m. to 4 p.m., Oct. 3

I patrolled the neighborhood and completed all 26 listed vacation watch checks. All homes were secure.

School was not in session today, so vehicle and foot traffic was light.

I checked the river access points and the parks. All were quiet.

Tuesday-Wednesday 8 p.m.-4 a.m., Oct. 4-5

I patrolled the neighborhood and completed all 23 listed vacation watch checks. All homes were secure.

I received an email about a gate malfunction at the Wyndgate community. I drove through that area a few extra times to make sure no suspicious people were creeping around.

I patrolled Shelato a few extra times in response to recently reported security issues there. All was quiet.

The river access points were clear. Not many people were out walking tonight.

Thursday 8 a.m.-4 p.m., Oct. 6

I patrolled the neighborhood and completed all 31 listed vacation watch checks. All homes were secure.

A resident waved me down on Estates Drive. He said he had been walking his dog and heard a gunshot near the river. I passed the information along to park rangers.

I patrolled each river access point. There were several cars at the Estates Drive access, but I observed no issues.

I monitored the stop sign at Jacob Lane and Keane Drive but saw no traffic violations while I was there.

I responded to two burglar alarms. Both were false.

The rest of the shift was quiet.

Friday 8 a.m.-4 p.m., Oct. 7

I patrolled the neighborhood and completed all 28 listed vacation watch checks. All homes were secure.

I drove by Rio Americano High School and the adjoining neighborhood, but observed no traffic or parking violations.

The rest of the shift was quiet.

Friday-Saturday, 8 p.m.-4 a.m., Oct. 7-8

I patrolled the neighborhood and completed all 36 listed vacation watch checks. All homes were secure.

I observed an open garage door on Haggin Grove. As I walked up to the front door, the nextdoor neighbor approached me and said she was just about to close it and thanked me for checking on it.

The Wyndgate entry gate was still not functional and could not be opened for a vehicle. So, I entered on foot, walked the entire neighborhood and checked on four houses that were on the vacation watch. Everything checked clear and I saw nothing was suspicious.

I observed that a home at the corner of Picadilly and American River Drive had been T-papered sometime during the night. There did not appear to be any other damage.

I observed some early morning joggers, but nothing unusual.

Monday 8 a.m. to 4 p.m., Oct. 10

I patrolled the neighborhood and completed all 35 listed vacation watch checks. All homes were secure.

I reviewed an email from a community member regarding a package theft from a porch. The theft occurred in the 3800 block of Exmoor Circle sometime on Saturday afternoon. The theft was not witnessed or caught on camera. The item was not expensive and was being replaced by the seller. I provided the resident with numerous tips to help prevent future thefts.

I received an email from a community member who reported smelling a strong electrical odor in the area of Marlborough and Sherlock Way. I checked with Metro Fire and there were no calls for service. I drove through the area, but did not smell anything unusual.

I received an email from a resident on Saverien Drive about Rio Americano student offcampus parking on her street. I advised her to call the non-emergency number (916) 874-5115 to have a parking enforcement officer dispatched whenever her driveway was

blocked or she observed other parking violations.

All river access points and parks checked clear.

IN AN EMERGENCY

If you have an immediate emergency - if your life or property is in immediate danger, if you feel threatened by someone on or near your property, if you have just become the victim of a crime or if you are witnessing a crime in progress:

- CALL 911 from a land line.
- Or, if calling from a cell phone within Sacramento County, call (916) 874-5111.

TO REPORT A CRIME

There are two ways to report a crime to the Sacramento County Sheriff's Department:

- 1. Call the Sheriff's Department NON-EMERGENCY LINE at (916) 874-5115. To bypass the recorded messaging when you call, dial 0 after the line is answered.
