

Twice-Monthly Patrol Report filed by WDDNA's Off-Duty Sheriff's Deputies

PATROL DEPUTY REPORTS

Past Two Weeks Reported in Chronological Order

Monday, Oct. 11

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I responded to an email from a resident who reported having an ongoing problem with her neighbor regarding a trailer.

I patrolled around the schools early in the morning, but observed no problems.

I was dispatched to a panic alarm in the 4100 block of Crondall Drive. The homeowner said technicians from her alarm company had just left after doing some maintenance.

Tuesday, Oct. 12

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I responded to reports of a transient near Jesuit High School. I could not locate him, but I did find another transient sleeping in the gutter on Philomene Court and had him go on his way.

Tuesday-Wednesday 10 p.m.-4 a.m., Oct. 12-13

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I responded to an email from a member asking about a police pursuit that occurred on Oct. 8. I was able to report that the case involved a stolen car and that the suspect was captured by a Sheriff's Department K9 unit.

Around 10 p.m., I saw a car in a ditch at Fair Oaks Boulevard and Estates Drive. I contacted the driver, who turned out to be a security guard who had pulled over to look at his phone and accidently went into the ditch. He contacted a tow truck.

At 11 p.m. I assisted patrol with an uncooperative subject who was reported to be trespassing near Fair Oaks Boulevard and Robin Lane. Patrol detained him and determined that he lived on the street with his girlfriend.

The neighborhood was quiet and I observed no traffic issues, but I did see some wildlife. There was a beautiful big deer eating a homeowner's flowers near Exeter and Crondall. And there was a family of raccoons causing mischief near Ashton and Dorking.

Wednesday Day, Oct. 13

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I stopped and cited a driver who went through a red light at Fair Oaks and Saveriern Drive.

I responded to a burglar alarm at a bank near Watt Avenue and Arden Way. It was false.

I was waved down by a parent who was unable to locate her 11-year-old daughter after school. After a search, she was located at a friend's house and was fine.

I monitored traffic after dismissal at both Rio Americano High School and Del Dayo Elementary School, but observed no violations.

Thursday Day, Oct. 14

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I monitored traffic on Crondall near Estates and issued a warning to a driver who failed to come to a complete stop at the stop sign.

The rest of the shift was quiet.

Saturday, Oct. 16

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I walked Ashton Park during the soccer games and checked in with staff at Jesuit High School where football games were underway.

I monitored traffic at the intersections of Jacob Lane and Oak Vista Drive, and Ashton Drive and American River Drive. I stopped six drivers and issued warnings, most for stop sign violations. In one case, the driver was driving while talking on a cell phone.

The rest of the shift was quiet.

Monday, Oct. 18

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I monitored traffic near Rio Americano High School after dismissal, but did not observe any reckless driving or illegal parking.

Tuesday, Oct. 19

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I responded to a report of a person going through recycle cans on Ashford. He was gone when I arrived, but I checked the surrounding area to be sure.

I responded to a report of a stolen chainsaw on Kingsford. Someone entered an unlocked gate and took a tree trimmer's chainsaw valued at \$750. The suspect left a bag at the scene which contained a tent. Because the suspect was likely homeless, I advised park rangers of the theft in case they contacted someone along the river with a chainsaw. I also searched the area, but did not find the suspect.

Tuesday-Wednesday 10 p.m.-4 a.m., Oct. 19-20

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

At 11:30 p.m. I responded to a report that a man wearing a gray sweatshirt and baseball cap had stolen keys from someone's car in the Del Dayo area. I searched the area, but did not find him.

Thursday Day, Oct. 21

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

At Crondall and Estates, I stopped and cited two drivers for failing to come to complete stops at the stop sign.

Later, I assisted patrol responding to a report of a suspicious subject on Crondall Drive near Estates. The caller said a homeless woman was trying to get into homes and was yelling. I arrived and found an older woman completely soaked from the rain. She was yelling that she needed an ambulance because of her heart issues. The fire department arrived and transported her to the hospital.

The rest of the shift was quiet.

Saturday, Oct. 23

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I monitored intersections off American River Drive at Saverien and Harrington for stop sign violations. I observed no violations while I was there. I continuously patrolled the parks and schools, circling around the area to make myself known.

- Or, if calling from a cell phone within Sacramento County, call (916) 874-5111.

TO REPORT A CRIME

There are two ways to report a crime to the Sacramento County Sheriff's Department:

- 1. Call the Sheriff's Department NON-EMERGENCY LINE at (916) 874-5115. To bypass the recorded messaging when you call, dial 0 after the line is answered.
