



Twice-Monthly Patrol Report filed by WDDNA's Off-Duty Sheriff's Deputies

PATROL DEPUTY REPORTS

Past Two Weeks Reported in Chronological Order

Tuesday-Wednesday 8 p.m.-4 a.m., Oct. 10-11

I patrolled the neighborhood and completed all 21 of the scheduled vacation watch checks. All homes appeared secure.

Tools had been reported stolen out of a truck one night last week in the vicinity of Susan Way, McClaren Drive and Arden Way. So, I spent time cruising through that area.

Wednesday 8 a.m.-4 p.m., Oct. 11

I patrolled the neighborhood and completed all 22 of the scheduled vacation watch checks. All homes appeared secure.

I responded to a report of a vehicle parked on Gordon Lane with the occupant asleep on the back seat. I determined that the vehicle had a flat tire. The driver checked clear and said he was waiting for a friend to bring him a new tire.

I responded to a report of a disturbance in the 1400 block of Gary Way. The caller reported that her father was very upset after being told his mother took him out of her will. The caller said her father threatened to kill his mother (who lives out of town). He had already driven away when we arrived at the scene.

I responded to an alarm in the 1300 block of Kingsford Way. It was false.

Wednesday 4-10 p.m., Oct. 11

I patrolled the neighborhood and completed all 20 of the scheduled vacation watch checks multiple times. All homes appeared secure.

Rio had a late event. I monitored traffic at Jacob and American River while football practice ended and I had a couple of drivers move along when I found them parked in bike lanes and at intersection corners.

All the parks and river access points checked clear.

Saturday, 4-10 p.m., Oct. 14

I patrolled the neighborhood and completed all 36 of the scheduled vacation watch checks. All homes appeared secure.

I spoke to several couples walking their dogs.

There were events at Jesuit, so I stayed in the area to monitor parking and traffic.

The river access points checked clear.

Sunday 8 a.m.-4 p.m., Oct. 15

I patrolled the neighborhood and completed all 33 of the scheduled vacation watch checks. All homes appeared secure.

I monitored traffic at several locations, but observed no violations.

There was heavier than usual pedestrian traffic today and I spoke to several residents.

I responded to a report of a residential burglary in progress in the area of Eastern Avenue and Fair Oaks Boulevard. I assisted as deputies established a perimeter. The subject initially escaped, but was later arrested by a Sheriff's patrol unit.

Monday 8 a.m. to 4 p.m., Oct. 16

I patrolled the neighborhood and completed all 26 of the scheduled vacation watch checks. All homes appeared secure.

I patrolled all river access locations, but observed no problems.

I monitored traffic at Jacob and Keene and cited three drivers for running the stop sign. Then I monitored Saverien and Ashton, where I cited two drivers for running the stop sign.

I contacted a woman near Ashton Park who had a couple of bags of empty cans she had collected. I spoke with her about what she was doing and places she could go outside of the neighborhood. She walked off and I later her saw her leaving the area on American River Drive near Watt Avenue.

Tuesday 8 a.m. to 4 p.m., Oct. 17

I patrolled the neighborhood and completed all 30 of the scheduled vacation watch checks. All homes appeared secure.

I received an email from a woman who reported seeing a man in a vehicle whom she thought matched the description of a subject that had been seen driving around waving and leering at female joggers. I communicated with her and she provided sufficient information to confirm that this was the same man. I kept an eye out for him, but did not locate a vehicle that fit the description.

I monitored traffic at several locations. I stopped a driver after he rolled through the stop sign at Ashton and Southwick Way. He said he was on his way to pick up his wife. His driver's license and vehicle documents were all current, so I issued a verbal warning.

Tuesday-Wednesday 8 p.m.-4 a.m., Oct. 17-18

I patrolled the neighborhood and completed all 28 of the scheduled vacation watch checks. All homes appeared secure.

I checked all the river access points, but observed nobody loitering in the area.

At 2:20 a.m. I noticed very thick smoke in the Del Dayo area up through the elementary school. I knew this was more than a fireplace. The fire department did not have anything reported yet, so I drove around the neighborhood making sure no homes or backyards were on fire.

At 2:30 a.m. I checked William B. Pond Park and located about a ½-acre brush fire burning on the bike trail directly south of the main entry kiosk. I called in Sacramento

Metro Fire to respond. I opened all the gates and bollards so they could have quicker access to the fire. Once the fire was extinguished, I left to continue patrolling the area.

Wednesday 4-10 p.m., Oct. 18

I patrolled the neighborhood and completed all 32 of the scheduled vacation watch checks. All homes appeared secure.

I monitored traffic at Jacob and American River Drive while football practice ended. Traffic moved smoothly and I observed no violations.

All the parks and river access points checked clear.

I monitored traffic at a few different intersections but observed no violations.

While patrolling, I noticed a garage door that had been left open. I contacted the homeowner, who thanked me for alerting him.

I stopped a driver who did not have operating taillights on her vehicle. She said she had borrowed the car from her son-in-law, so I helped her locate a switch to get the lights working.

Sunday 8 a.m.-4 p.m., Oct. 22

I patrolled the neighborhood and completed all 33 of the scheduled vacation watch checks. All homes appeared secure.

I monitored traffic at several intersections, but observed no violations.

I was advised of vandalism to a mailbox at a home on Gordon, so I contacted the resident and advised her of her options.

Monday 8 a.m. to 4 p.m., Oct. 23

I patrolled the neighborhood and completed all 27 of the scheduled vacation watch checks. All homes appeared secure.

I monitored school traffic in the morning, but observed no violations.

I checked on the parks and river access points and found them free of any problems or suspicious vehicles.

I monitored the intersection of Estates and American River Drive, but observed no traffic violations.

Tuesday 8 a.m. to 4 p.m., Oct. 24

I patrolled the neighborhood and completed all 28 of the scheduled vacation watch checks. All homes appeared secure.

I helped several neighbors to round up two loose dogs in the area of Bentley and Carmelo.

I monitored the intersection of Ashton Drive and Offham Court, where I cited one driver for rolling through the stop sign and gave a verbal warning to a second. Then I monitored Crondall Drive and the intersection of Ashton and Morris, but observed no violations.

When Rio Americano High School let out, I was on Saverien Drive near Fair Oaks Boulevard, where I saw several drivers use the bike lane to make right-hand turns. Bicyclists were forced to weave between cars. Due to heavy traffic, I was only able to stop one driver and issue a verbal warning.

- Or, if calling from a cell phone within Sacramento County, call (916) 874-5111.

TO REPORT A CRIME

1. Call the Sheriff's Department NON-EMERGENCY LINE at (916) 874-5115. To bypass the recorded messaging when you call, dial 0 after the line is answered.
