## PATROL DEPUTY REPORTS

Past Two Weeks Reported in Chronological Order

### **Tuesday-Wednesday 10 p.m.-4 a.m., Nov. 23-24**

I patrolled the neighborhood and completed all listed vacation watch checks. All homes appeared secure.

Traffic was minimal. I monitored Rio Americano High in response to an email about cars speeding in the parking lot at night. I observed no bad behavior tonight.

### **Thursday Day, Nov. 25**

I patrolled the neighborhood and completed all listed vacation watch checks. All homes appeared secure.

I received an email about a bicycle theft on Wycombe Way. I responded to the residence, but no one was home.

The rest of the shift was quiet.

### **Saturday, Nov. 27**

I patrolled the neighborhood and completed all listed vacation watch checks. All homes appeared secure, except one which had an unlocked rear sliding glass door. The alarm was set off and I notified the homeowner.

I responded to a residential panic alarm on Estates Drive. The alarm had been activated by mistake.

The rest of the shift was quiet.

### **Saturday Night, Nov. 28**

I patrolled the neighborhood and completed all listed vacation watch checks. All homes appeared secure.

I responded to a burglar alarm on Wyndgate. The alarm came from the living room motion detector. I determined that the exterior of the home was secure, but I could see several cats in the living room playing with their toys. I called the homeowner and left a message that everything appeared secure.

I stopped a driver for speeding near American River Drive and Saverien Drive. I advised him that the speed limit is 25 mph in residential areas.

### **Monday, Nov. 29**

I patrolled the neighborhood and completed all listed vacation watch checks. All homes appeared secure.

I responded to an email from a member who reported that she had five packages stolen from her porch in the 800 block of Morris Way the previous day. She made an online report. The vehicle was described as a four-door white sedan.

I monitored traffic at Rio Americano and Jesuit high schools at the beginning of school. Traffic was heavy but I observed no traffic violations.

Towards the end of my shift, I met with an elderly resident who was concerned about someone tampering with her garage door key pad. I advised her of some options.

### **Tuesday, Nov. 30**

I patrolled the neighborhood and completed all listed vacation watch checks. All homes appeared secure.

I responded to an incomplete 911 call on Gary Way. It appeared to have been a mistake.

I responded to a call about an assault on American River Drive. The complainant chose not to file a report.



### **Tuesday-Wednesday 10 p.m.-4 a.m., Nov. 30-Dec. 1**

I patrolled the neighborhood and completed all listed vacation watch checks. All homes appeared secure.

I received an email from a member who had pictures of a car used by a thief who had stolen packages on Saturday, Nov. 27. The homeowner had already filed an online report. **Above is a cropped image of the vehicle. Note that the car has two different rim types on the passenger side.** (If you see this vehicle in the neighborhood and can obtain a license number, please contact the Sheriff's Department non-emergency line at (916) 874-5115 and provide the information.)

I removed a large traffic cone I found in the middle of American River Drive so no cars would strike it at night. I am not sure if it was placed there on purpose or if it fell off a work vehicle.

While I was conducting vacation checks, I could hear cars doing donuts somewhere in the neighborhood. Since there were previous reports of this behavior in the Rio Americano High School parking lot, I checked there first, but could not locate the car.

### **Thursday Day, Dec. 2**

I patrolled the neighborhood and completed all listed vacation watch checks. All homes appeared secure.

I received two emails about package thefts at different times of the day involving two different sedans, one white and the other gray.

While on patrol, I found a Siberian Husky running loose on Thistlewood. I took the dog to the local vet, where they scanned for a microchip. The dog had a chip, so I obtained the owner's information and returned it to its owner on Brickwell.

The rest of the shift was quiet.

### **Friday Day, Dec. 3**

I patrolled the neighborhood and completed all listed vacation watch checks. All homes appeared secure.

I responded to a report of a suspicious person on McClaren Drive. I determined that the subject was lost and I gave him a courtesy ride back to his home.

I responded to an audible alarm on Thornley Way. It appeared to be false.

The rest of the shift was quiet.

### **Saturday, Dec. 4**

I patrolled the neighborhood and completed all listed vacation watch checks. All homes appeared secure.

I assisted patrol checking on the welfare of a resident in a home near Woodacre Court. We determined that an elderly woman had passed away from natural causes. I spoke with neighbors and expressed my deepest condolences.

There was a tournament at Ashton Park, so I drove the area multiple times during my shift.

### **Monday, Dec. 6**

I patrolled the neighborhood and completed all listed vacation watch checks. All homes appeared secure. I found a package that had been delivered at one of the homes and noticed that the house number was the same but the street was wrong. The street was just around the corner, so I removed the package and delivered it to the correct address.

I patrolled the schools in the morning. The traffic was heavy as usual, but I observed no violations.

I responded to a report of a homeless woman lying in a ditch at American River Drive and Kingsford. When I arrived, I found the woman sitting up and asked her if she was okay. She said she was fine and that she would leave the area.

### **Tuesday, Dec. 7**

I patrolled the neighborhood and completed all listed vacation watch checks. All homes appeared secure.

The Sheriff's Department parking patrol unit cited numerous vehicles parked illegally near Rio Americano High School.

### **Tuesday-Wednesday 10 p.m.-4 a.m., Dec. 7-8**

I patrolled the neighborhood and completed all listed vacation watch checks. All homes appeared secure.

Traffic was very light and the rest of the shift was quiet.

**Thursday Day, Dec. 9**

I patrolled the neighborhood and completed all listed vacation watch checks. All homes appeared secure.

I stopped several vehicles and cited the drivers for failing to stop at the sign near Crondall and Estates.

I assisted patrol responding to a report of a suspicious vehicle parked on the sidewalk. The vehicle was registered to the area, but I could not reach the owner, so a parking citation was issued.

The rest of the shift was quiet.

**Friday Day, Dec. 10**

I patrolled the neighborhood and completed all listed vacation watch checks. All homes appeared secure.

I monitored traffic during dismissal at Rio Americano High School. I stopped a driver at American River Drive and Saverien Drive for a crosswalk violation and issued a warning.

The rest of the shift was quiet.

**IN AN EMERGENCY**

If you have an immediate emergency - if your life or property is in immediate danger, if you feel threatened by someone on or near your property, if you have just become the victim of a crime or if you are witnessing a crime in progress:

- CALL 911 from a land line.
- Or, if calling from a cell phone within Sacramento County, call (916) 874-5111.

**TO REPORT A CRIME**

There are two ways to report a crime to the Sacramento County Sheriff's Department:

1. Call the Sheriff's Department NON-EMERGENCY LINE at (916) 874-5115. To bypass the recorded messaging when you call, dial 0 after the line is answered.
