



Twice-Monthly Patrol Report filed by WDDNA's Off-Duty Sheriff's Deputies

PATROL DEPUTY REPORTS

Past Two Weeks Reported in Chronological Order

Friday Day, Feb. 11

I patrolled the neighborhood and completed all 23 listed vacation watch checks. All homes were secure.

I was waved down by a resident about a bicycle accident on Arden Way just west of Kingsford Drive. I arrived on scene and contacted the 12-year-old boy who said he had hit a curb while checking his cell phone. A passerby and I stayed with him until his father arrived.

I assisted patrol with a vehicle pursuit. A wanted felon was traveling toward the neighborhood, but was apprehended before he reached the Wilhaggin area.

Saturday, Feb. 12

I patrolled the neighborhood and completed all 18 listed vacation watch checks. All homes were secure.

I responded to a report of a transient who had been seen screaming at a passerby on American River Drive under the Watt Avenue bridge. I was unable to locate the subject.

I responded to a 911 hang-up call at the Sheriff's Academy, but determined that everything was okay.

I stopped and cited a driver for running the stop sign at Jacob Lane and Oak Vista Drive.

I visited a garage sale to chat with residents and handed out stickers to the kids.

I came upon a lemonade stand off Kipling Drive and stopped to chat with the kids. A young lady was raising money for a pet cat. I purchased a drink and gave them stickers.

Sunday, Feb. 13

I patrolled the neighborhood and completed all 28 listed vacation watch checks. All homes were secure.

I responded to a report of a bicyclist down on the bike trail at Harrington. The rider was shaken up, but said she was OK.

I responded to a report of an incomplete 911 call from Jesuit High School. Someone at the school contacted the Sheriff's Department to cancel the call prior to my arrival.

I checked North River several times in response to a report of a homeless person scavenging in a recycling bin, but did not locate the subject.

Monday, Feb. 14

I patrolled the neighborhood and completed all 23 listed vacation watch checks. All homes were secure. I located packages on the front porches of two homes and moved them out

of sight.

A Mission Oaks Recreation and Parks District employee reported some writing at Ashton Park. The writer said that he felt like hurting others and himself. I documented the incident and park employees removed the writing.

I responded to a burglar alarm in the 700 block of Whitehall Way at a home on the vacation watch list. The home appeared secure and I emailed the homeowner about the incident.

I received an email reporting reckless driving by teenagers around Ashton Park. I drove to the park and observed a few cars with a group of 10 teenagers standing around them. I parked on the street and watched them. They left soon after.

I checked the river access points and gated neighborhoods. All were quiet.

Monday Night, Feb. 14-15

I patrolled the neighborhood and completed all 21 listed vacation watch checks. All homes were secure.

I checked Ashton Park, the schools and the levee access points multiple times throughout the night.

I responded to a report of a family disturbance on American River Drive. It had been resolved by the time I arrived.

I stopped and cited two drivers for running the stop sign in front of Rio Americano High School.

I received an email from a homeowner about a garage door problem on Kingsford Drive. I checked the house and advised the owner.

Tuesday, Feb. 15

I patrolled the neighborhood and completed all 19 listed vacation watch checks. All homes were secure.

At one home, I observed wet footprints leading away from the pool. I contacted the homeowners, who had been out of town for several days. They advised me that no one should have been in the pool. I observed no other suspicious activity at the house, so I alerted other Wilhaggin deputies to give extra attention to the house.

I was contacted by a driver who requested that I sign off on a citation.

I monitored several stop signs, but issued no citations.

Tuesday-Wednesday 10 p.m.-4 a.m., Feb. 15-16

I patrolled the neighborhood and completed all 17 listed vacation watch checks. All homes were secure.

I checked all the river access points, but observed no issues.

There were very few cars on the road and no pedestrians. It was a quiet night.

Wednesday Day, Feb. 16

I patrolled the neighborhood and completed all 17 listed vacation watch checks. All homes were secure.

I responded to a burglar alarm in the 4800 block of Keane Drive. It was false.

I received an email from a resident about a Rio Americano High School student who had parked a car blocking a handicap curb ramp on Saverien Drive. I cited the vehicle for the violation. The penalty is a \$407.50 fine.

I took a report from a resident in the Wyndgate area who said she was getting bothersome

texts and voice mails from the spouse of a former patient.

I checked all the river accesses points and hiding places. All were clear.

Thursday Day, Feb. 17

I patrolled the neighborhood and completed all 18 listed vacation watch checks. All homes were secure.

I monitored the intersection at Crondall and Estates before school and cited one driver for speeding.

I drove down Bailey Way between Morris Way and Saverien Drive during school hours. I observed some parked vehicles, but they were all legally parked.

The rest of the shift was quiet.

Friday Day, Feb. 18

I patrolled the neighborhood and completed all 22 listed vacation watch checks. All homes were secure.

I assisted patrol checking on the welfare of an individual who has addresses in both San Francisco and our neighborhood. The individual had not been seen at the San Francisco home for several days, but was located and was OK.

Friday Night, 7 p.m.-3 a.m., Feb. 18-19

I patrolled the neighborhood and completed all 21 listed vacation watch checks. All homes were secure.

I cited a driver for a registration violation near Arden Way and Fair Oaks Boulevard.

As I was driving on American River Drive around 12:30 a.m., I heard screeching tires coming from Rio Americano High School. As I drove into the school, I observed a black Mustang doing several donuts in the parking lot, generating a large plume of smoke. I stopped the 19-year-old driver and sole occupant, who said he was just letting off steam after getting off work at a pizza parlor. I cited him for exhibition of speed.

An hour later I came cross a carload of male juveniles parked in the Rio Americano parking lot. None of them lived in the area and I had them leave.

During the course of my shift, I checked Rio Americano five times. Each time, I found cars in the parking lot with juveniles inside just "chilling." Finally, I parked in the lot for about 30 minutes and watched cars enter and then leave as soon as they saw me. This is becoming a very frequent problem.

I checked all the river access points and all were quiet.

Saturday, Feb. 19

I patrolled the neighborhood and completed all 23 listed vacation watch checks. All homes were secure. One residence had a sliding glass door that was loose on its track. It triggered the alarm when I tested it, so I notified the homeowner.

Most of the shift was uneventful. Traffic was heavier than usual with people visiting the river parkway areas.

Saturday Night, Feb. 19-20

I came on duty around 4 p.m. and saw an email sent around 2:50 p.m. from a member in the 4100 block of Crondall who was not at home but said his Ring camera had caught images of a man who seemed suspicious. I drove around the area but did not locate the subject. I checked the home to make sure it was secure and found a package that had been left on the patio. I emailed the homeowner and reported my findings.

I patrolled the neighborhood and completed all 29 listed vacation watch checks. All homes were secure.

There were about 10-12 cars loaded with teens at Rio Americano at 9:30 p.m. hanging out. Due to concerns about mischief, noise, inappropriate and unsafe driving, I cleared them out of the parking lot.

I checked the river access points, but observed nothing of concern.

Sunday, Feb. 20

I patrolled the neighborhood and completed all 35 listed vacation watch checks. All homes were secure. One had an open gate, but I found no sign of any attempted entry. I closed the gate when I finished my walk-through.

I received an email in the late afternoon about teenagers in a small silver pickup truck, but I did not find anyone matching the description at Jesuit High School or William Pond Park.

When sending an email directly to the off-duty deputy, it can be helpful to include your phone number so that we can call you for additional information. Because we are often in and out of our vehicles, you should not rely on email if you are reporting anything urgent. Instead, you should call the Sheriff's Department non-emergency phone number: (916) 874-5115. If one of us is on duty, we will be alerted. If not, a unit will be sent from out of the neighborhood.

Monday, Feb. 21

I patrolled the neighborhood and completed all 30 listed vacation watch checks. All homes were secure.

Today was President's Day. San Juan Schools were closed and will be for the remainder of the week.

I checked the river access points and gated communities. All checked clear.

Tuesday, Feb. 22

I patrolled the neighborhood and completed all 27 listed vacation watch checks. All homes were secure.

I responded to a burglar alarm on Oak Vista. I contacted two painters in the backyard who said that they likely set off the alarm when they opened the garage door looking for a power outlet. Nothing appeared suspicious.

Tuesday-Wednesday 10 p.m.-4 a.m., Feb. 22-23

I patrolled the neighborhood and completed all 27 listed vacation watch checks. All homes were secure.

I responded to an email about a car driving down Gordon Lane, checking a homeowner's mail box, then driving away.

I responded to a burglar alarm on Stowe Way. It appeared that the home was either being remodeled or being prepared for an estate sale. No one answered the door or responded on the ring camera. The exterior appeared secure so I cleared the call.

There were 10-12 cars loaded with teenagers in the Rio Americano High School parking lot again around 8:30 p.m. I cleared them out with my car P.A. system.

While I was checking a vacation watch home on Guildford Court, I was waved down by the homeowners' son. He told me there was a car in the driveway of his parents' house that he did not recognize. I checked vehicle records and determined that the car belonged to a dog walker who was taking his parents' dog out for its a nightly walk.

I checked the river access points and all were clear.

IN AN EMERGENCY

If you have an immediate emergency - if your life or property is in immediate danger, if you feel threatened by someone on or near your property, if you have just become the victim of a crime or if you are witnessing a crime in progress:

- CALL 911 from a land line.
- Or, if calling from a cell phone within Sacramento County, call (916) 874-5111.

TO REPORT A CRIME

There are two ways to report a crime to the Sacramento County Sheriff's Department:

1. Call the Sheriff's Department NON-EMERGENCY LINE at (916) 874-5115. To bypass the recorded messaging when you call, dial 0 after the line is answered.

If you see someone engaged in suspicious activity but it is not an emergency, call 916-874-5115 (Sheriff's Department non-emergency line).
