PATROL DEPUTY REPORTS

Past Two Weeks Reported in Chronological Order

Monday, Jan. 25

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes appeared secure.

I toured all gated communities and checked the river access points. All was quiet.

I spoke with a resident whose security camera showed that a passenger in a white or silver Ford F150 got out and peered into his parked truck and checked his mailbox. The activity was around 11:30 p.m. and again near 6 a.m. No theft occurred.

Tuesday-Wednesday 10 p.m.-4 a.m., Jan. 26-27

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes appeared secure.

I checked the schools and all the river access points. All was quiet.

There were multiple power outages in the area and multiple trees down in the roadways. I cleared several trees as best I could without equipment.:

I responded to two burglar alarms. Both were false. I responded to a request to check on the welfare of some elderly residents. They were fine.

Wednesday Day, Jan. 27

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes appeared secure. At one home part of a fence was damaged, possibly due to weather. I emailed the residents and notified them of the damage.

There were several large branches and a downed power line in the road on Ashton Drive. I did my best to clear the branches. Several tree companies, SMUD and other utility company vehicles were in the area clearing the roads and restoring power to the neighborhood.

I assisted patrol deputies with four different burglar alarms. All had been activated when the power was restored, tripping the systems.

Thursday Midnight-6 a.m., Jan. 28

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes appeared secure.

I checked the schools and all river access points. All appeared secure.

There were still some downed trees in the roadway, but most had been cleared. The shift was otherwise quiet.

Thursday Day, Jan. 28

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes appeared secure.

It was raining all day and pedestrian traffic was light.

I responded to a report of a family disturbance. All was calm when I arrived.

The rest of the shift was quiet.

Friday Day, Jan. 29

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes appeared secure.

As I was checking homes, I received a report of a burglary at an unoccupied home in the 1600 block of Del Dayo Drive. The owner said the burglar kicked in the front door on Dec. 30 and a report had been filed. Then on Jan. 26, the gardener reported that a rear door had been pried open. China, flatware and bicycles were taken. I took the burglary report.

Friday Night, Jan. 29-30

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes appeared secure.

At approximately 11 p.m. I responded to the area of Fair Oaks Boulevard and Jacob Lane after the homeowner reported that a man was in his driveway trying to get into the boat that was parked there. I viewed the surveillance camera footage and began to look for the subject, but could not find him. Later that night, I returned to the home because the suspect had returned and attempted to open the garage door. I again searched the area, but could not find him. I called for a sheriff's helicopter to respond with night vision and heat seeking equipment, but a helicopter was not available. I continued to look for the suspect while patrolling the area and received no further calls about the subject.

I checked all river accesses and monitored intersections for traffic violations. All was quiet.

Saturday, Jan. 30

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes appeared secure.

Traffic in the neighborhood was lighter than normal.

Saturday-Sunday 10 p.m.-4 a.m., Jan. 30-31

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes appeared secure.

At approximately 11 p.m. I responded to the area of American River Drive and Jacob Lane. The homeowner said someone had knocked loudly on his door and asked that I check the area. I was unable to locate the subject.

I checked all river access points, monitored intersections for traffic violations and checked the parks. All was quiet.

Monday, Feb. 1

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes appeared secure.

I observed an unattended motorhome parked on Estates Drive near American River Drive. I have received numerous similar complaints about it being parked overnight all along American River Drive from Howe Avenue to Saverien Drive. It had a "For Sale" sign in the window – a county ordinance violation – so I cited it.

I responded to a call at Fair Oaks Boulevard and Arden Way about a man harassing the employees at McDonalds. While I was on my way, he moved to the EI Forastero restaurant and was creating a disturbance there. The caller said the man was taking off his clothes and throwing them onto Fair Oaks Boulevard. I arrived, along with two CHP units, and located the intoxicated man in front of the UPS store. He was in an agitated state and was wearing only a pair of loose-fitting pants. He was on active parole, so I arrested him for parole violation and public intoxication and booked him at the main jail.

Wednesday Day, Feb. 3

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes appeared secure.

I took a theft report on Morris Way. Someone had stolen the resident's catalytic converter from his 2008 Toyota Prius during the night.

I cited an 18-year-old resident for blowing through a stop sign and dealt with a female transient who was soliciting for money outside businesses at Arden and Eastern.

It was quiet otherwise.

Thursday Midnight-6 a.m., Feb. 4

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes appeared secure.

I observed a white Ford SUV traveling on American River Drive with an expired license plate. I stopped the vehicle and determined that none of the occupants were from the area and did not know anyone who lived here. The driver had an outstanding arrest warrant, so I placed him in custody and advised the other occupants to leave the area.

After taking the subject to jail, I checked the schools and all the river access points. The river access gate at Harrington Way was open. I checked the area, but there were no vehicles or people around.

Thursday Day, Feb. 4

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes appeared secure.

The rest of the shift was quiet.

Friday Day, Feb. 5

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes appeared secure.

There were a lot of residents out and about. A resident told me that a vehicle was illegally parked in front of a fire hydrant, but it was gone when I checked it.

I patrolled a few intersections for stop sign violations, but observed none.

Friday Night, Feb. 5-6

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes appeared secure.

It was a very quiet evening. River accesses were empty, as were school parking lots.

Saturday, Feb. 6

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes appeared secure. One home had an interior alarm malfunction. The home appeared secure so I notified the homeowner.

I followed up on a report about a possible vandalized car. The vehicle was gone when I arrived.

I answered a homeowner's question regarding a motor home seen parking throughout the community.

Saturday-Sunday 10 p.m.-4 a.m., Feb. 6-7

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes appeared secure.

I patrolled the major intersections, levee access points and parks. It was very cold and not much was moving tonight.

Monday, Feb. 8

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes appeared secure.

The shift was quiet. Vehicle traffic was light.

Tuesday, Feb. 9

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes appeared secure.

I responded to member emails about a suspicious vehicle and about two loose dogs.

There were many pedestrians out today, but few bicycles.

Wednesday Day, Feb. 10

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes appeared secure. One home had a beeping sound coming from the interior, but the home appeared secure. I reported the sound to the homeowner.

I monitored the intersections at American River Drive and Saverien, Wilhaggin and Estates for stop-sign violations. I observed none.

I checked the river access points and all were clear.

I saw an email about two dogs running loose in the area of Paisley Way. I drove around the area multiple times but did not see the dogs.

I assisted patrol responding to a panic alarm on Raimer Way. It turned out to have been accidental.
