## PATROL DEPUTY REPORTS

### Past Two Weeks Reported in Chronological Order

#### **Thursday Midnight-6 a.m., Feb. 11**

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

I checked the schools and all the river access points. There was no activity to report.

The shift was quiet.

#### **Thursday Day, Feb. 11**

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

Pedestrian traffic was light. I did have to remind several motorists to turn their lights on in the rain.

I assisted patrol with a burglar alarm on Estates Drive. It was a false alarm; the home was secure.

I assisted patrol with stopping a vehicle. The occupants and the vehicle were wanted in connection with a series of thefts from Bed Bath and Beyond. The vehicle, occupied by three subjects, was traveling west on Fair Oaks Boulevard and was eventually stopped near Howe Avenue. We detained the subjects and recovered the stolen merchandise.

The rest of the shift was quiet.

#### **Friday Day, Feb. 12**

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

I responded to two alarm calls, both of which turned out to be false. One was in the 3800 block of Exmoor Circle; the other was in the 1200 block of Gary Way.

I responded to a traffic accident at Arden Way and La Sierra Drive involving a collision between a vehicle and a bicycle. CHP ultimately handled it.

I assisted another unit with traffic control at a car crash on Monroe near Fair Oaks Boulevard.

I stopped and admonished a driver at Fair Oaks Boulevard and Arden Way for making an unsafe turn.

The rest of the shift was quiet.

#### **Friday Night, Feb. 12-13**

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

I saw an open garage door after midnight and contacted the homeowner, who was very grateful.

I checked river access points throughout the night but observed no activity.

I monitored traffic at key intersections in the neighborhood, but observed no violations or suspicious vehicles.

### **Saturday, Feb. 13**

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

I checked a previously burglarized home off Del Dayo Drive and noticed that a gate was broken and lying on the ground. I checked the yard, but could not determine if the damage was new. I contacted the homeowner, who confirmed some of the issues were pre-existing.

Traffic was light and I observed no traffic violations.

### **Monday, Feb. 15**

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

All river access points checked clear. The remainder of the morning was quiet.

### **Tuesday, Feb. 16**

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

I responded to an email from a resident regarding continuous issues with nearby dogs. I replied with helpful information.

Ashton Park was busy throughout the day and I stopped to chat with several homeowners.

I located an out-of-state SUV with an expired registration parked near Ashton Park. I was able to locate the registered owner and he checked out to be okay.

### **Tuesday-Wednesday 10 p.m.-4 a.m., Feb. 16-17**

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

I responded to a disturbance at one of the gas stations at Watt and Fair Oaks Boulevard. I resolved the call without incident.

The rest of the shift was quiet.

### **Wednesday Day, Feb. 17**

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

I stopped and cited a non-resident driver at Fair Oaks Boulevard and Eastern for a registration violation.

I responded to a report of a transient on Fair Oaks Boulevard, but he was gone when I arrived.

It was a quiet day otherwise.

### **Thursday Midnight-6 a.m., Feb. 18**

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

I responded to a resident who was concerned about a neighbor. I spoke with the resident for a few minutes.

The rest of the shift was quiet.

### **Thursday Day, Feb. 18**

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

I answered an email from a member whose elderly neighbor thought someone had been sleeping in their backyard at night. I checked the backyard, but was unable to determine if anyone had been there. I advised the homeowner to call the non-emergency number if anyone was seen sleeping there.

I responded to a request from a member to drive by the home of her elderly mother, who was home alone while the daughter was out on an errand. I drove by and everything appeared ok.

I was dispatched to assist patrol with stopping a stolen vehicle if it came close to the neighborhood. However, the vehicle in question crashed near American River College after a short pursuit and all the occupants were detained, so I was not needed.

The rest of the shift was quiet.

### **Friday Day, Feb. 19**

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

It was raining in the morning and pretty quiet in the neighborhood. By the afternoon, there were many people out. One WDDNA member stopped me to let me know about possible vandalism to the internet box on his property. He was unsure how the damage occurred and said the internet company was coming out to repair it. I advised him to email us if they determined it had been vandalized.

I monitored traffic at Wilhaggin and American River Drive and at Arden Way and Kingsford. I observed no egregious stop sign violations, but the presence of the patrol vehicle definitely caught people's attention

### **Friday Night, Feb. 19-20**

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

I checked all the river access points and all were clear.

I chased out about 10 carloads of kids from Rio Americano High School around 10 p.m.. I located a man sitting in his car at Arden Way and McClaren Drive. He said he was taking his nightly walk near the park. He was not a resident but checked clear.

Otherwise it was a quiet evening.

### **Saturday, Feb. 20**

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

I responded to a resident's request for assistance with a found wallet containing ID, money and credit cards. I eventually located the owner and the wallet was returned.

I met with three residents in Wyndgate and provided them with information about our patrols.

### **Saturday-Sunday 10 p.m.-4 a.m., Feb. 20-21**

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

I checked Rio Americano High School, Ashton Park and the levee access points for people hanging out. There were some kids at Rio and I had them leave the campus.

I responded to a report of a loud party. I determined that there were a number of people in the house, but the noise was not out of hand. I spoke to the homeowner, who said she knew her son was having some friends over. Most of the people left while I was there.

I stopped a driver for running the stop sign in front of Rio Americano High School. The driver appeared under the influence of alcohol. CHP responded and the driver was arrested for DUI. CHP towed the vehicle. The driver and passenger were also cited for having multiple fake drivers licenses in their possession.

### **Monday, Feb. 22**

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

I located a tan RV on Ashton Drive near American River Drive. It had been mentioned in previous reports. The vehicle was unoccupied and legally parked. It appears that the RV is moved periodically and the driver of the vehicle has yet to be contacted. I was unable to confirm if the owner lives nearby.

The remainder of the shift was quiet.

### **Tuesday-Wednesday 10 p.m.-4 a.m., Feb. 23-24**

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

I contacted the occupants of a vehicle parked at the dead end of Jacob. The occupants were young adults just hanging out.

I stopped a vehicle at Kingsford and Arden and determined that the driver lived nearby and checked clear.

I located a hit-and-run vehicle at Tennyson and American River Drive. I helped a woman at the scene and waited with her until CHP responded.

### **Wednesday Day, Feb. 24**

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

I saw an email about a suspicious RV in the area of American River Drive and Estates. I located the vehicle at approximately 8:15 a.m. It was unoccupied, legally parked, had a current registration and was not violating any codes. I spoke to a nearby resident, who said someone may be living in the RV and moving it from place to place. I placed a 72-hour parking green tag on it and photographed its position.

I located a white Lexus sedan that had been parking illegally in the Gary Way area. I had cited the vehicle before for lack of a parking permit and cited it again today.

I monitored traffic at the intersection of McLaren and Shelato but observed no traffic violations.
