

Twice-Monthly Patrol Report filed by WDDNA's Off-Duty Sheriff's Deputies



## PATROL DEPUTY REPORTS

### Past Two Weeks Reported in Chronological Order

#### **Thursday Midnight-6 a.m., Feb. 25**

I patrolled the entire neighborhood and completed all scheduled vacation watch checks. All homes appeared secure.

I responded to a report of a homeless person who may have been casing houses. I went to the homeless camp where the reporting party said the subject lives, but could not find anyone matching the description.

There was little traffic.

#### **Thursday Day, Feb. 25**

I patrolled the entire neighborhood and completed all scheduled vacation watch checks. All homes appeared secure.

I assisted patrol responding to a report of loud music at a home on Saverien Drive. It was quiet when I arrived. I advised the complainant of other options if the noise continued.

I stopped a vehicle for speeding and cited the driver.

#### **Friday Day, Feb. 26**

I patrolled the entire neighborhood and completed all scheduled vacation watch checks. All homes appeared secure.

I responded to a complaint in the 600 block of Regency Circle about a fifth-wheel vehicle that had been parked there for over a week. I cited the vehicle for having an expired registration and parking in a residential neighborhood. The owner came out and I explained the situation. She said she would move the vehicle.

I responded to a report that an unknown man had attacked a frail, 79-year-old woman in Loehmann's Plaza. The suspect fled, but several witnesses chased him down and held him until we got there. He was arrested for elder abuse and booked into the County Jail.

#### **Friday Night, Feb. 26-27**

I patrolled the entire neighborhood and completed all scheduled vacation watch checks. All homes appeared secure.

I checked all river access points several times, monitored intersections and checked houses under constructions. All was quiet.

#### **Saturday, Feb. 27**

I patrolled the entire neighborhood and completed all scheduled vacation watch checks. All homes appeared secure.

A resident reported seeing a small, black hatchback racing on Marlborough Way around 1 a.m., but was unable to get a license plate number. I will inform other night shift deputies.

At 9:02 a.m. I observed a vehicle driving through the stop sign at American River Drive and Jacob Lane. I stopped and cited the driver.

I assisted patrol searching for a homeless person who was reportedly running in and out of traffic on Fair Oaks Boulevard at Watt Avenue. I drove the area, but was unable to locate the subject.

I received a report from a resident about a man in his 40s, wearing a grey hoodie and blue jeans and riding a reddish-colored bike. The complainant said the man rode his bike straight toward her and her husband while they were out walking. At her request, I searched the area but was unable to locate anyone matching the description.

The rest of the shift was quiet.

### **Saturday-Sunday 10 p.m.-4 a.m., Feb. 27-28**

I patrolled the entire neighborhood and completed all scheduled vacation watch checks. All homes appeared secure.

I monitored major intersections for vehicle code violations.

Around 12:30 a.m., I noticed a man on a bike with no lights. I contacted him near Wilhaggin and American River drives. He was acting strange and when I tried to detain him, he took off. After a short chase, I detained him on Exmoor Drive. I determined that he had an outstanding felony warrant for identity theft. I arrested him for resisting a peace officer and transported him to the Sacramento County Main Jail.

The rest of the night was quiet.

### **Monday, March 1**

I patrolled the entire neighborhood and completed all scheduled vacation watch checks. All homes appeared secure.

I checked all river access points and all were clear. It was a quiet and beautiful day.

### **Tuesday, March 2**

I patrolled the entire neighborhood and completed all scheduled vacation watch checks. All homes appeared secure.

I stopped several vehicles for traffic infractions and issued one citation for running a stop sign.

I responded to a call on Lantern Court about a possible case of battery, but determined that the complaint was unfounded.

I spoke with a WDDNA member on Macaulay Court who expressed concerns about an increase in porch pirates and homeless people in the area.

### **Tuesday-Wednesday 10 p.m.-4 a.m., March 2-3**

I patrolled the entire neighborhood and completed all scheduled vacation watch checks. All homes appeared secure.

I checked all the river access points, schools and Ashton Park. All was quiet.

### **Wednesday Day, March 3**

I patrolled the entire neighborhood and completed all scheduled vacation watch checks. All homes appeared secure.

I checked all the river access points and found them empty.

I monitored traffic on American River Drive at Wilhaggin and at Estates and Wycombe. I observed no violations today.

### **Thursday Midnight-6 a.m., March 4**

I patrolled the entire neighborhood and completed all scheduled vacation watch checks. All homes appeared secure.

I checked the schools, Ashton Park and all the river access points. All were quiet.

#### **Thursday Day, March 4**

I patrolled the entire neighborhood and completed all scheduled vacation watch checks. All homes appeared secure.

I observed a vehicle speeding on American River Drive, pulled up beside him when he stopped and advised him to slow down.

I stopped and cited a 19-year-old driver who was traveling approximately 50 mph on American River Drive near Rio Americano High School.

#### **Friday Day, March 5**

I patrolled the entire neighborhood and completed all scheduled vacation watch checks. All homes appeared secure.

I was around Crondall Drive when I received an email about a car and motorcycle parking at night and possibly staying in a tent somewhere nearby. I checked, but observed no vehicles or tents. I spoke to the complainant, who said the man had not shown up last night, but had been there consistently before that.

I was waived down by a resident who reported that her black spaniel had gotten loose. I circled the neighborhood but was unable to find the dog.

I was waived down by a resident who reported that a blue Mazda Miata had been doing doughnuts at the intersection of Wilhaggin Drive and Grovesnor Court just prior to my arrival. I stopped a blue Mazda Miata a few hours later, but was unable to determine if the driver was the subject in question. He was from the Carmichael area, but said he was just passing through the neighborhood.

I monitored stop signs on American River Drive and issued a warning to one driver for rolling through a sign.

I followed FedEx and Amazon trucks and watched a few houses after deliveries had been made, but I observed no porch pirates or their vehicles.

#### **Friday Night, March 5-6**

I patrolled the entire neighborhood and completed all scheduled vacation watch checks. All homes appeared secure.

A resident reported that a motorcycle was parked in front of their home in the 3800 block of American River Drive. It was gone when I arrived.

Another resident reported seeing two cars parked overnight in front of a vacant lot on Crondall Drive. Both cars were legally parked, but I cited one of them for having an expired registration.

I checked all the river access points and schools. All was quiet.

#### **Saturday, March 6**

I patrolled the entire neighborhood and completed all scheduled vacation watch checks. All homes appeared secure.

I followed up on an earlier email from a resident about a possible Parkway camper who parks throughout the neighborhood. I looked extensively for such a person without success.

I patrolled Ashton Park and all river access points but observed no problems.

#### **Saturday-Sunday 10 p.m.-4 a.m., March 6-7**

I patrolled the entire neighborhood and completed all scheduled vacation watch checks. All homes appeared secure.

I checked Ashton Park, the schools and all levee access points. All were clear.

I cited one driver for running a stop sign in front of Rio Americano High School and for having an expired registration. I cited a second driver for driving over 50 mph on American River Drive.

#### **Monday, March 8**

I patrolled the entire neighborhood and completed all scheduled vacation watch checks. All homes appeared secure.

The remainder of the shift was calm.

### **Tuesday, March 9**

I patrolled the entire neighborhood and completed all scheduled vacation watch checks. All homes appeared secure.

I was contacted by a WDDNA board member about an RV that had been observed moving between two parking locations and staying for several days at a time. It appears the driver is intentionally trying to avoid the 72-hour parking limit. I started an email chain for other deputies to keep track of the vehicle in an effort to solve the problem.

### **Tuesday-Wednesday 10 p.m.-4 a.m., March 9-10**

I patrolled the entire neighborhood and completed all scheduled vacation watch checks. All homes appeared secure.

I checked schools and all the river access points. All were clear.

The rest of the shift was quiet.

### **Wednesday Day, March 10**

I patrolled the entire neighborhood and completed all scheduled vacation watch checks. All homes appeared secure.

I read the patrol log about an RV seen parking around American River Drive, Estates and Ashton. I drove around the area multiple times, but was unable to locate it.

I checked river access points and the schools multiple times.

I assisted patrol with a residential burglar alarm on Genesee Court. The home was secure and the alarm was deemed to be accidental.

It was a quiet day with minimal traffic.
