PATROL DEPUTY REPORTS

Past Two Weeks Reported in Chronological Order

Tuesday, Jan. 12

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

There was very little pedestrian and bicycle traffic today.

I responded to a report of a possible prowler in a backyard on Marlboro, but I was unable to locate a suspect.

Tuesday-Wednesday 10 p.m.-4 a.m., Jan. 12-13

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I responded to a report by a resident who said she saw a subject in her backyard with a gun. I arrived on scene quickly and searched the backyard, but was unable to locate anyone in the yard.

Wednesday Day, Jan. 13

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I received an email about a possible porch pirate who may have been active around Claydon Way and Estates Drive Tuesday night. I advised the residents of security and surveillance system options.

I encountered a two-vehicle fender bender at Fair Oaks Boulevard and San Lucas Way. The two parties exchanged information without the assistance.

Thursday Day, Jan. 14

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I observed a vehicle parked illegally in a permit parking area near Arden and Gary ways. I issued a citation.

I stopped a vehicle for a minor traffic violation and gave the driver a verbal warning.

The rest of the shift was quiet.

Saturday, Jan. 16

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

Early in the morning, I observed a male adult carrying plastic bags walking eastbound on American River Drive at Shelato Way. He appeared to be lost, so I spoke with him, gave him directions to his destination and watched as he walked to Arden Way and left the neighborhood.

I assisted patrol responding to a report of a woman who was crossing Fair Oaks Boulevard and appeared to be yelling. We determined that she did not need assistance and watched as she left the area.

The rest of the shift was quiet.

Tuesday, Jan. 19

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I responded to a vehicle crash on Fair Oaks Boulevard at Mission Avenue. The fire hydrant was struck, so Lantern Court had minor flooding. CHP responded and Metro Fire shut off the water.

I participated in the processional for K9 Riley, the Sheriff's Department service animal that was killed in a shooting at Cal Expo along with Deputy Adam Gibson.

Tuesday-Wednesday 10 p.m.-4 a.m., Jan. 19-20

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure. The shift was quiet and uneventful.

Thursday Midnight-6 a.m., Jan. 21

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I checked all river access points, Ashton Park and the two schools and all was quiet and secure.

Thursday Day, Jan. 21

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure. The rest of the shift was quiet.

Friday Day, Jan. 22

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I responded to a report of an abandoned bicycle on Cortlandt Drive, but it had been removed when I arrived.

I responded to an alarm on Thornley Way, but the homeowner confirmed that the activation was accidental.

The rest of the shift was quiet.

Friday Night, Jan. 22-23

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I stopped a bicyclist on Jacob Lane at Oak Vista around midnight. He was flying down American River Drive, passing slow cars and failing to stop at stop signs. I determined that he was a nearby resident riding home from his swing shift downtown.

Around 2 a.m., I located a vehicle in the middle of the Chase Bank parking lot at Fair Oaks Boulevard and San Lucas. The car's lights were on and the driver was slumped over in his seat. I determined that he was a Door Dash driver who had fallen asleep.

As I was clearing that call, I observed an older dark Infinity with two occupants creeping around La Sierra Drive. I stopped the car and determined that the driver was a discharged parolee and the passenger was on felony probation. Neither of them lived nearby and neither could explain what they were doing in the area.

I noticed that the passenger was trying to open his door to get out, but was having difficulty because he had something sitting between his legs. I detained both occupants and searched the car. I found a jack on the floorboard in front of the passenger seat with the 3-foot jack handle that had been protruding up between the passenger's legs. The car was full of tools consistent with those used in catalytic converter thefts, but I found no catalytic converters in the car. Although both subjects had widely different stories, they checked clear, so I had to release them. I will report the incident and the two subjects to the Sheriff's Department detective who handles the theft of precious metals.

Saturday-Sunday 10 p.m.-4 a.m., Jan. 23-24

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I checked Rio Americano High School and I found some young people there sitting in their cars eating ice cream. I advised them to leave the property.

I checked Ashton Park and the levee access points. All was clear. I monitored major intersections for

traffic violations, but observed none. It was a quiet night.
