

Twice-Monthly Patrol Report filed by WDDNA's Off-Duty Sheriff's Deputies

PATROL DEPUTY REPORTS

Past Two Weeks Reported in Chronological Order

Friday-Saturday, 8 p.m.-4 a.m., Feb. 24-25

I patrolled the neighborhood and completed all 24 scheduled vacation watch checks. All homes appeared secure.

Tonight was cold and wet. Very few pedestrians and vehicles were out.

I contacted a resident who called the communications center regarding a Sheriff's vehicle across the street from her home. I told her about the WDDNA neighborhood patrol. She was not aware of our service.

Sunday 8 a.m.-4 p.m., Feb. 26

I patrolled the neighborhood and completed all 26 scheduled vacation watch checks. All homes appeared secure.

I responded to an alarm at WIlhaggin Estate Apartments. The office appeared secure.

The rest of the shift was quiet.

Monday 8 a.m. to 4 p.m., Feb. 27

I patrolled the neighborhood and completed all 18 scheduled vacation watch checks. All homes appeared secure.

It rained on and off today. Schools were back in session and traffic was moderate.

I responded to a request for a welfare check and was able to report that the person was well and doing fine.

The parks and river access points were clear.

Wednesday 4-10 p.m., March 1

I patrolled the neighborhood and completed all 18 scheduled vacation watch checks. All homes appeared secure.

I responded to Ashton Park in response to a report that two neighbors had taken a walk around the park and discovered that the gates were locked when they returned to their vehicles. I was able to get the security company to arrive and open the gate.

Late in the evening I noticed a house with an open garage door. I was unable to reach the

homeowner, so I contacted a neighbor, who was able to reach them and let them know to close the door.

Thursday 8 a.m.-4 p.m., March 2

I patrolled the neighborhood and completed all 25 scheduled vacation watch checks. All homes appeared secure.

I responded to an alarm in the 1300 Block of Kingsford Way. The home and gates were secure.

I responded to another alarm in the 1200 Block of Gary Way. The alarm had been activated from a side garage door. When I arrived, a neighbor was watching the door, which was slightly ajar. An additional unit arrived and we checked the interior of the home, which was clear; nothing had been taken. It appeared that the door had been left unlocked. The homeowner was informed of the situation.

I responded to an email regarding a homeless encampment near the levee behind the County Assessor's office. The resident reported being taunted by the homeless subjects as they walked their dog. I reached out to the Sheriff's Department Homeless Outreach Team (HOT) and advised them of the encampment.

The rest of the shift was quiet.

Saturday, 8 a.m. - 4 p.m., March 4

I patrolled the neighborhood and completed all 27 scheduled vacation watch checks. All homes appeared secure.

I followed up with the encampment by the levee . Park Rangers assisted me in detaining the man and two women in their respective tents near the pump station along the bike trail. All subjects were issued misdemeanor citations for littering within 150 feet of a waterway. I advised all of them to clean up the area and move along.

I stopped and cited a driver who went through the intersection at Estates and Wycome in excess of 15 mph. The passenger explained that she was in a hurry because they were late to her bridal shower. The driver's driving record was less than stellar, so I advised him to be more careful to avoid having his license suspended.

The rest of the shift was quiet.

Sunday 8 a.m.-4 p.m., March 5

I patrolled the neighborhood and completed all 29 scheduled vacation watch checks. All homes appeared secure.

I checked the area in the morning, but found no trees down despite recent high winds.

I responded to a complaint filed the evening before. A couple had been walking in William Pond Park and saw two different vehicles racing around, spinning brodies, etc. The reporting man yelled at the drivers and one of the cars stopped. He walked towards the car to tell the driver not to drive that way in the park. He believed that there were two boys in the car. As he approached, the car sped away and both cars left the park.

The man was able to get the license plate number of one of the vehicles, a black Jeep. It was registered to an address just outside of the neighborhood. I went to that home and

saw the Jeep parked in the driveway. I knocked, but nobody answered, so I left my business card.

(The next morning, the father of the teenage driver contacted the WDDNA deputy. He reportedly was receptive and said he would speak with his son, who is a Jesuit student.)

It was otherwise a very quiet shift.

Monday 8 a.m. to 4 p.m., March 6

I patrolled the neighborhood and completed all 20 scheduled vacation watch checks. All homes appeared secure.

I patrolled the river access points. Despite the cool weather there were several people out walking around, enjoying the area.

I monitored the intersections of Jacob and Keane and of Saverien and Ashton, but observed no traffic violations.

Tuesday-Wednesday 8 p.m.-4 a.m., March 7-8

I patrolled the neighborhood and completed all 18 scheduled vacation watch checks. All homes appeared secure.

All the river access points were quiet and streets had very light traffic. It started to get cold and rainy around 1:30 a.m.

I monitored the intersection of Estates and American River Drive. One person driving a truck locked up his breaks when he noticed me at the last moment. He stopped lawfully, but I stopped him and had a chat about slowing down and paying attention to signs.

I monitored the intersections of Jacob and Keane, as well as Kingsford and Arden. Everyone behaved.

Thursday 8 a.m.-4 p.m., March 9

I patrolled the neighborhood and completed all 23 scheduled vacation watch checks. All homes appeared secure.

I took a report from a Saverien Drive homeowner whose house had been egged and glass bottles had been broken in the driveway.

I responded to a report of a transient sleeping at a business near Fair Oaks Boulevard and Watt Avenue. I woke the subject and he gathered his belongings and left the area. He checked clear for any wants or warrants.

The rest of the shift was quiet.

Friday 8 a.m.-4 p.m., March 10

I patrolled the neighborhood and completed 25 scheduled vacation watch checks. All homes appeared secure.

I stopped and issued a warning to a driver who went through the intersection of Wilhaggin Drive and Fair Oaks Boulevard against a red light.

I responded to an alarm in the 500 block of Grovesnor Court. There was no answer at the door and the residence appeared to be secure.

I responded to an alarm in the 4900 block of Marlborough Way. The activation was due to owner error.

The rest of the shift was quiet

- Or, if calling from a cell phone within Sacramento County, call (916) 874-5111.

TO REPORT A CRIME

There are two ways to report a crime to the Sacramento County Sheriff's Department:

- 1. Call the Sheriff's Department NON-EMERGENCY LINE at (916) 874-5115. To bypass the recorded messaging when you call, dial 0 after the line is answered.
