# PATROL DEPUTY REPORTS

Past Two Weeks Reported in Chronological Order

# Sunday 8 a.m.-4 p.m., March 12

I patrolled the neighborhood and completed all 25 scheduled vacation watch checks. All homes appeared secure.

I contacted a resident on Wilhaggin Drive who reported seeing a gold pickup truck parked across the street with a male driver in his 30s or 40s who was using a cell phone to photograph her home. When she opened her blinds, he immediately rolled up his window and drove away. The homeowner said she had not seen him before and was unable to get the license plate of his vehicle.

It rained off and on all day. Traffic was very light.

# Monday 8 a.m. to 4 p.m., March 13

I patrolled the neighborhood and completed all 17 scheduled vacation watch checks. All homes appeared secure.

I was waved down by a man who wanted to add a vacation watch for his 95-year-old neighbor who is a WDDNA member and will be hospitalized for an extended period. I set up an extended vacation watch order.

I patrolled all the river access points. There were a few people out.

I monitored the stop sign at Jacob and Keane, but observed no traffic violations.

I switched over to the stop sign at Saverien and Ashton Drive. There were a few close calls, but everyone stopped at the limit lines.

#### Tuesday 8 a.m. to 4 p.m., March 14

I patrolled the neighborhood and completed all 16 scheduled vacation watch checks. All homes appeared secure.

It was a very windy and stormy day.

I responded to alarms in the 1600 block of Del Dayo Drive and the 2000 block of Clarement Road. Both were false.

I came upon a downed tree on Sandbar Circle near Riffle Court that blocked the roadway. I alerted county maintenance staff to remove it from the street.

I was waved down in the business complex at 3510 American River Drive about an abandoned car that had been there for a few days. I determined that it was not stolen and that the property representative would have it towed.

I assisted patrol removing a transient from the Wells Fargo Bank at Fair Oaks and Monroe Street.

# Tuesday-Wednesday 8 p.m.-4 a.m., March 14-15

I patrolled the neighborhood and completed all 16 scheduled vacation watch checks. All homes appeared secure.

I checked the usual river access points. All were quiet.

Around 9:30 p.m. I received an email from a homeowner who reported seeing a vehicle peel out near Wilhaggin and American River Drive and sent a video of the incident. The vehicle appeared to be a Mercedes with one headlight out. The homeowner was concerned that this had often occurred around 8 p.m. I emailed the homeowner that I would keep an eye out for the vehicle. I also monitored his intersection for 30 minutes in case the driver returned.

Late in my shift, I receive an email about the theft of personal property from a gym at Arden and Fair Oaks Boulevard. I responded to the email to assist her in filing an online report.

#### Wednesday 8 a.m.-4 p.m., March 15

I patrolled the neighborhood and completed all 16 scheduled vacation watch checks. All homes appeared secure.

I contacted a homeowner in the 5400 block of Shelato Way regarding a theft yesterday at the gym at Arden Way and Fair Oaks Boulevard. The suspect had snapped the locks in the locker room and stolen credit cards and cash. I went to her home and took the report.

I was waved down on Keane Drive by a transient who had cut her finger while taking items out of a resident's recycle cart. She wanted a bandage for her finger. I advised her that taking items from a recycle cart is illegal and that she should leave the area. She drove away in her vehicle.

A resident in Sierra Oaks called about a suspicious vehicle (a white subcompact) with two men in hoodies, cruising slowly on Huntington Way. There have been a couple of residential burglaries in that area in the last two weeks.

Otherwise, it was a quiet day.

#### Thursday 8 a.m.-4 p.m., March 16

I patrolled the neighborhood and completed all 19 scheduled vacation watch checks. All homes appeared secure.

I followed up with a member who emailed about a possible abandoned vehicle near Jacob Lane and the river access. The vehicle was described as a sedan with out-of-state plates. I drove to the location, but the vehicle was not there. I reported my findings to the member.

The rest of the shift was quiet.

#### Friday 8 a.m.-4 p.m., March 17

I patrolled the neighborhood and completed all 20 scheduled vacation watch checks. All homes appeared secure.

The rest of the shift was quiet.

#### Saturday, 4-10 p.m., March 18

I patrolled the neighborhood and completed all 18 scheduled vacation watch checks. All homes appeared secure.

A member emailed me to ask that I stop by their home on Keane Drive to move a package from the front door to the back patio. I responded to the house within five minutes and did so.

Several children ages 7 to 10 came up to me on Keane Drive to say hello. I chatted with them and passed out some Sheriff stickers.

I responded to a report of cars parking near the stop sign in front of the condos on Robin Lane. The homeowner asked if there were any parking violations. I checked the site and advised the homeowner that cars are legally allowed to park within the area described.

There were no other calls for service.

#### Monday 8 a.m. to 4 p.m., March 20

I patrolled the neighborhood and completed all 18 scheduled vacation watch checks. All homes appeared secure.

San Juan Schools were out today, which minimized traffic.

I responded to an email from a member who had witnessed a vehicle doing donuts the previous evening. I advised the member how to report it if it occurred again.

I was dispatched to an alarm in the 800 block of Lake Oak Court. While I was on my way, the alarm company cancelled the call.

I was dispatched to a possible domestic violence situation in a bathroom at Bella Bru. The caller reported hearing yelling and banging on the walls. Upon my arrival, I was advised that the incident involved a transient male alone in the bathroom and that he had left the restaurant.

All the parks and river access points checked clear..

#### Tuesday 8 a.m. to 4 p.m., March 21

I patrolled the neighborhood and completed all 15 scheduled vacation watch checks. All homes appeared secure.

It rained most of the day and there was very little foot or vehicle traffic. I did not see any vehicle violations that required a stop.

I drove by Del Dayo Elementary School, Rio Americano High School and Jesuit High School, but observed no suspicious activity.

I followed up with a resident on Paisley Way who had called for service Monday. I suggested options regarding a neighbor dispute.

# Tuesday-Wednesday 8 p.m.-4 a.m., March 21-22

I patrolled the neighborhood and completed all 14 scheduled vacation watch checks. All homes appeared secure.

There have been several emails during the last two weeks asking patrol to monitor Estates

Drive and Fair Oaks Boulevard for drivers doing doughnuts. I spent about 35 minutes monitoring the intersection, but observed no issues.

I spent time monitoring Rodante Way, Kevington Court and Gordon Lane in response to concerns about transients walking through at night.

I checked the river access points for any transient issues. The weather kept everyone inside tonight.

#### Wednesday 8 a.m.-4 p.m., March 22

I patrolled the neighborhood and completed all 16 scheduled vacation watch checks. All homes appeared secure.

I responded to an alarm in the 3600 block of American River Drive. It turned out to be false.

I observed no traffic violations during my shift and the river access points checked clear.

# Wednesday 4-10 p.m., March 22

I patrolled the neighborhood and completed all 14 scheduled vacation watch checks. All homes appeared secure.

I observed no problems in the neighborhood. It was a quiet night.

# Thursday 8 a.m.-4 p.m., March 23

I patrolled the neighborhood and completed all 13 scheduled vacation watch checks. All homes appeared secure.

The rest of the shift was quiet.

#### IN AN EMERGENCY

If you have an immediate emergency - if your life or property is in immediate danger, if you feel threatened by someone on or near your property, if you have just become the victim of a crime or if you are witnessing a crime in progress:

- · CALL 911 from a land line.
- Or, if calling from a cell phone within Sacramento County, call (916) 874-5111.

#### TO REPORT A CRIME

There are two ways to report a crime to the Sacramento County Sheriff's Department:

- 1. Call the Sheriff's Department NON-EMERGENCY LINE at (916) 874-5115. To bypass the recorded messaging when you call, dial 0 after the line is answered.
