PATROL DEPUTY REPORTS

Past Two Weeks Reported in Chronological Order

FROM A MEMBER

Sometime in late March the catalytic converter was stolen from our GMC truck that was parked in our driveway on Piccadilly Circle.

FROM PATROL DEPUTIES

Thursday Day, March 25

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

I cited a driver for going 60 m.p.h. on Fair Oaks Boulevard.

The rest of the shift was uneventful.

Friday Day, March 26

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

I monitored traffic at Del Dayo Elementary School and Rio Americano High School, but observed no issues.

I received an email from a resident regarding found property and the person was able to return it to the owner before I arrived.

The rest of the shift was quiet.

Friday Night, March 26-27

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

I monitored vehicle traffic at several intersections and checked all river access points several times.

I responded to Jacob Lane and Sherlock Drive in response to a report that juveniles were taking down a street sign. I arrived at scene within two minutes but observed no juveniles or any vandalism. I tried to call the reporting party, but there was no answer.

Saturday-Sunday 10 p.m.-4 a.m., March 27-28

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

I checked the parks and schools. They all checked clear. It was a very quiet night.

Tuesday, March 30

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were

secure.

I monitored traffic at several stop signs, but observed no violations. I checked all river access points and all were clear.

Tuesday-Wednesday 10 p.m.-4 a.m., March 30-31

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

I checked all the river access points, the schools and the park. All was quiet.

Wednesday Day, March 31

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

I cited a parked car in the 3900 block of Crondall for a registration violation.

I cited a motorist for running a red light at Saverein Drive and Fair Oaks Boulevard.

All the river access points were quiet.

Thursday Midnight-6 a.m., April 1

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

I checked both schools and all river access points. All were quiet.

Thursday Day, April 1

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

I helped a lost driver find Arden Way. The rest of the shift was uneventful.

Friday Day, April 2

I patrolled the entire neighborhood and completed all listed vacation watch checks. Most homes were secure. While checking rear sliding glass doors, I found two that were unsecured. I contacted the residents and reported the incidents.

I met with a resident who reported the theft of a catalytic converter and gave advice on enhanced security measures.

A resident gave me a Nissan key fob that was found near the pay drop boxes at the Harrington river access. There were no Nissan vehicles in the parking lot so I booked the key for safe keeping under report #21-96154.

I monitored major stop signs but observed no violations.

Friday Night, April 2-3

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

I came upon a hit-and-run accident at Fair Oaks Boulevard and Arden Way in which a vehicle had crashed into a utility pole. CHP arrived to handle the crash. Otherwise, it was a quiet evening.

Saturday, April 3

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

I responded to the 3800 block of American River Drive for a 911 cell phone hang-up. It turned out that the person had pocket dialed 911 by accident.

I responded to a fire alarm call in the 1200 block of Lantern Court. A handyman had set off the alarm by accident.

The rest of the shift was uneventful.

Tuesday, April 6

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

I responded to two burglar alarms. Both were false.

I responded to several reports of a female transient who was causing a disturbance. Near the end of my shift, I located her at Estates and Fair Oaks Boulevard, where she was caught spray painting a sign. I arrested her and booked her for vandalism.

Tuesday-Wednesday 10 p.m.-4 a.m., April 6-7

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

I responded to a message from a resident inquiring about lost items.

Both schools appeared secure and there was no activity near the river access points. The shift was quiet.

Thursday Midnight-6 a.m., April 8

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

I checked both schools and all the river access points. All appeared secure.

I contacted a person sleeping in a vehicle at the William B. Pond access. The subject checked clear and I advised him to leave the area.

The rest of the shift was quiet.

Thursday Day, April 8

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

There was a vehicle parked on Crondall near the vacant lot. It was legally parked and I didn't see anyone around the area who might have been associated with it.

I assisted patrol with an incomplete 911 call near Jesuit High School. It turned out to be an accidental call.

The rest of the shift was uneventful.

Friday Day, April 9

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

The rest of the shift was quiet.

Friday Night, April 9-10

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

I checked all river access points. At one of them, I contacted a couple in a parked car who appeared to be smoking marijuana. I advised them to leave the area and they complied.

I observed a male bicycling aimlessly around the neighborhood, so I followed him as he left the area.

Saturday, April 10

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes were secure.

I assisted another deputy at Ashton Park. He had contacted a subject on active probation with an older model black Toyota in the parking lot that had no license plates. We conducted a probation search of the vehicle, but did not locate anything criminal. We told the subject that he was trespassing and not to return to the park.

I visited a garage sale where a resident gave me ammunition that he had found in the home of his late mother. I took the ammunition to the Sheriff's Department range and turned it over to the staff for destruction.

The rest of the shift was quiet.
