



Twice-Monthly Patrol Report filed by WDDNA's Off-Duty Sheriff's Deputies

PATROL DEPUTY REPORTS

Past Two Weeks Reported in Chronological Order

Monday 8 a.m. to 4 p.m., March 25

I patrolled the neighborhood and completed all 24 vacation watch checks. All homes appeared secure.

I responded to a member concerned about parking around Jesuit High School during sporting events.

I responded to a burglar alarm in the 4200 block of North River Way. It appeared to be false.

All parks and river access points were clear of any problems or issues.

I monitored the intersection of American River Drive and Jacob Lane, but observed no traffic violations.

Tuesday 8 a.m. to 4 p.m., March 26

I patrolled the neighborhood and completed all 25 vacation watch checks. All homes appeared secure.

I stopped and issued a verbal warning to a driver who failed to come to a complete stop at the three-way stop at Jacob Lane and Keane Drive.

As a follow-up to the report I took about a porch pirate theft on Dovercourt Circle last week, I met with the victim, obtained their Ring video and completed my report.

I cited a parked vehicle that was partially blocking the pedestrian crossing at Crondall Drive and Estates.

I monitored several intersections but observed no traffic violations.

Tuesday-Wednesday 8 p.m.-4 a.m., March 26-67

I patrolled the neighborhood and completed all 25 vacation watch checks. All homes appeared secure.

There were a few people walking their dogs on Ashton Drive, so I stopped to chat with one of them.

All parks and river access points checked clear. There were three teenagers hanging

around the Rio Americano High School campus. I shined my light at them from the street and they left the area.

It was a very peaceful night.

Wednesday 9 a.m.-4 p.m., March 27

I patrolled the neighborhood and completed all 24 vacation watch checks. All homes appeared secure.

Rio Americano High School and Del Dayo School were closed for the holiday. Jesuit High School was in session.

It rained off and on all day. All river access points checked clear and I observed no transients in the area. It was a quiet day.

Thursday 8 a.m.-4 p.m., March 28

I patrolled the neighborhood and completed all 28 vacation watch checks. All homes appeared secure.

I stopped and issued a verbal warning to a driver who failed to observe the stop sign and Estates and American River Drive.

Schools were out of session for the week, so I saw no parking violations.

Friday 8 a.m.-4 p.m., March 29

I patrolled the neighborhood and completed all 29 vacation watch checks. All homes appeared secure.

I monitored several intersections, but observed no traffic violations.

It was a cloudy, rainy and windy day, so there was very little foot or vehicle traffic.

I responded to an alarm on American River Drive. A rear door was left unsecured and the wind blew it open. I checked the interior and it checked clear. A person arrived on scene and secured the home.

Friday-Saturday, 8 p.m.-4 a.m., March 29-30

I patrolled the neighborhood and completed all 25 vacation watch checks. All homes appeared secure.

I noticed that the gate access to William Pond Park was wide open. There were three homeless individuals near the gate inside the parking lot and I advised them that the park was closed. All three checked clear and I sent them on their way out of the neighborhood. The gate remained open all night, so I checked on it several times during my shift.

It was raining, so foot and vehicle traffic was minimal tonight, but there was a group of joggers around 1 a.m. on American River Drive.

I checked all the parks, schools and river access points. The gate to the Rio Americano High School parking lot had been left open, so I checked on the school throughout the night.

I monitored traffic at key intersections, but very few cars were on the road.

Saturday, 8 a.m. – 4 p.m., March 30

I patrolled the neighborhood and completed all vacation watch checks. All homes appeared secure.

I responded to a report about a truck that had been parked on Wilhaggin Drive for several days. I had parking enforcement issue a 72-hour notice. I cited a second vehicle for being parked on the sidewalk.

It was raining steadily during my shift, so traffic and pedestrian travel was light.

I checked the park, schools and river access points and all were quiet.

Monday 8 a.m. to 4 p.m., April 1

I patrolled the neighborhood and completed all 23 vacation watch checks. All homes appeared secure.

I answered a homeowner's question regarding some trash on Fair Oaks Boulevard.

I checked on all parks and river access points. All checked clear of any problems. I monitored the intersection at American River Drive and Jacob Lane, but observed no traffic violations.

Tuesday-Wednesday 8 p.m.-4 a.m., April 2-3

I patrolled the neighborhood and completed all 24 vacation watch checks. All homes appeared secure.

I received an email around midnight asking me to check the AT&T box along Fair Oaks Boulevard and Columbia for a possible transient living at that location. There were no current signs of anyone living there. It is a very small area and visible from the street, so it may have been used as a stopping point at one time.

Traffic was light throughout the night.

Wednesday 8 a.m.-4 p.m., April 3

I patrolled the neighborhood and completed all 26 vacation watch checks. All homes appeared secure.

All the river access points checked clear.

I received an email from a member whose house was vandalized this weekend and whose son is being bullied at Rio Americano High School. I stopped by the home in the 4200 block of North River Way and met with the member and his wife. They said that their 16-year-old son is a Rio student and is having issues with a 17-year-old boy at school who lives in Sierra Oaks. They said kids have come by late at night the past few nights and thrown food scraps and garbage in front of their house, on the porch and in the mailbox. They believe the Rio student is responsible. They have contacted the principal at Rio and plan to meet with the boy's parents about the situation.

Thursday 8 a.m.-4 p.m., April 4

I patrolled the neighborhood and completed all 26 vacation watch checks. All homes appeared secure.

I stopped and cited two drivers for failing to stop at the stop sign at Harrington and American River Drive.

I checked around the high schools, but did not see any parking violations.

Monday 8 a.m. to 4 p.m., April 8

I patrolled the neighborhood and completed all 28 vacation watch checks. All homes appeared secure.

I responded to a member's concern regarding subjects sleeping in their vehicles overnight at the end of Jacob Lane.

I checked on the parks and river access points multiple times, but observed no problems or issues.

I monitored the intersection at American River Drive and Estates Drive. I didn't observe any traffic violations.

Tuesday 8 a.m. to 4 p.m., April 9

I patrolled the neighborhood and completed all 28 vacation watch checks. All homes appeared secure.

I contacted a member who wanted to add information about her vacation watch. At a home on Selsey Court the gardeners had left the side gate wide open. I checked the perimeter, but observed no signs of forced entry. I secured the gate and emailed the owners so they could advise their gardener.

I noted that there were reports of people sleeping in parked vehicles at the end of Jacob Lane. I kept an eye on Jacob Lane and various similar locations but did not see any vehicles that seemed lived in.

I was waved down at Morris and American River Drive by a homeowner who reported possible homeless individuals who were camping at night on the south side of Fair Oaks Boulevard between Columbia and Treehouse Lane. There are some shrubs that partially conceal them. He said he believes the subjects were using drugs and making a lot of noise. I advised him to call the Sheriff's Department non-emergency number while the subjects are there so that deputies can respond immediately.

I checked the river access points and cited one vehicle that had an expired registration and was parked in a no-stopping zone on Harrington Way.

Tuesday-Wednesday 8 p.m.-4 a.m., April 9-10

I patrolled the neighborhood and completed all 25 vacation watch checks. All homes appeared secure.

In response to an earlier report of drug-using campers on Fair Oaks Boulevard, I checked that area from Cortlandt Drive to Lake Oak Court. I did not see any signs of long-term encampments and did not locate anyone sleeping or staying in the bushes. This is the second such report in recent weeks, so it is an area that may be a short-term stopping spot for transients, rather than a camp. The best option is to call the non-emergency line immediately when such activity is observed so it can be addressed within a couple of hours. The phone number is (916) 874-5115.

I responded to a report of a person possibly sleeping in a car at the end of Jacob Lane near the river access point. I checked multiple times throughout the night, but did not see a car parked there. It should be noted that it is legal for someone to park at night as long as there is not a "no parking" sign at that location. It is only illegal if there is a "no parking" sign there.

Wednesday 8 a.m.-4 p.m., April 10

I patrolled the neighborhood and completed all 26 vacation watch checks. All homes appeared secure.

I assisted civil deputies serving a temporary restraining and move-out court order at a home in the 4100 block of Stowe Way. The adult male left without incident.

I responded to a request to check on the welfare of an elderly woman in the 4200 block of Stowe Way. I determined that she was fine and did not need assistance.

I checked all river access points. All were empty.

I cited a driver for a stop sign violation on Estates Drive at Wycombe Drive.

IN AN EMERGENCY

If you have an immediate emergency - if your life or property is in immediate danger, if you feel threatened by someone on or near your property, if you have just become the victim of a crime or if you are witnessing a crime in progress:

- CALL 911 from a land line.
- Or, if calling from a cell phone within Sacramento County, call (916) 874-5111.

TO REPORT A CRIME

There are two ways to report a crime to the Sacramento County Sheriff's Department:

1. Call the Sheriff's Department NON-EMERGENCY LINE at (916) 874-5115. To bypass the recorded messaging when you call, dial 0 after the line is answered.

SUSPICIOUS ACTIVITY (Not an emergency)

If you see someone engaged in suspicious activity but it is not an emergency, call 916-874-5115 (Sheriff's Department non-emergency line).
