

Twice-Monthly Patrol Report filed by WDDNA's Off-Duty Sheriff's Deputies

PATROL DEPUTY REPORTS

Past Two Weeks Reported in Chronological Order

Tuesday-Wednesday 8 p.m.-4 a.m., May 10-11

I patrolled the neighborhood and completed all 17 listed vacation watch checks. All homes appeared secure.

There were no issues at the American River access points. The high school parking lot was quiet.

The night was uneventful. I monitored several intersections for stop sign violators early in the shift. Everyone appeared to driving at a safe speed and stopping at the intersections.

Wednesday 8 a.m.-4 p.m., May 11

I patrolled the neighborhood and completed all 15 listed vacation watch checks. All homes appeared secure.

I drove all the streets numerous times, checking river accesses and hiding spots. Everything was quiet.

I was waved down by a resident who reported seeing a car dropping off a woman who went through trash cans. I stopped the vehicle on Jacob Lane. It was driven by a man who said he was helping a friend make some extra money by collecting recyclable trash, but he could not remember her name. He checked clear and I advised him to stay out of the area.

I responded to a 911 call in the 4200 block of North River Way. An elderly man answered the door and said his wife had a small accident inside, that he was going to drive her to the hospital and that he did not need my help. I said I would stand by while he got her into his car. While I was standing on the front porch, I heard a loud woman's scream from inside the house. The man ran up to me and said "she has fallen down and cannot get up!" I went in to help and found his elderly wife on her knees, face-down on the floor, screaming that her shoulders hurt. She reportedly had a prior medical condition that had been aggravated when she fell. I assisted the husband get her into a wheelchair, wheel her out to his car and get her in. I offered medical assistance from Metro Fire several times, but both subjects declined.

Thursday 8 a.m.-4 p.m., May 12

I patrolled the neighborhood and completed all 25 listed vacation watch checks. All homes appeared secure.

I assisted the California Highway Patrol near Folsom Boulevard and La Riviera Drive. A solo officer was dealing with an uncooperative homeless woman and was struggling with her on the ground. I arrived and the officer managed to get the subject handcuffed. I returned to the Wilhaggin area and resumed my patrol.

I stopped and issued a warning to a driver who did not come to a full stop at the Crondall and Estates sign.

I drove by the schools and cited a vehicle for a parking violation on Whitehall. The vehicle was parked more than 18 inches from the curb.

Friday-Saturday, 8 p.m.-4 a.m., May 13-14

I patrolled the neighborhood and completed all 24 listed vacation watch checks. All homes appeared secure.

I responded to a report of juveniles skateboarding in the Rio Americano High School parking lot. They left when I arrived.

I came across several carloads of juveniles parked just outside Rio's new locked gates late at night. I had them leave.

I responded to a report of rowdy juveniles at Shelfield Park and had them clear out.

As I drove by Del Dayo School, there were a number of juveniles parked in the parking lot late at night. I had them leave.

Other than dealing with juveniles all night, it was a quiet evening.

Saturday-Sunday 8 p.m.-4 a.m., May 14-15

I patrolled the neighborhood and completed all 24 listed vacation watch checks. All homes appeared secure.

I received a report from a WDDNA member about a rude driver who had passed the member on American River Drive. The homeowner wanted us to be aware of the truck. I responded, noting that we cannot enforce traffic laws when violations are not committed in our presence. Nevertheless, I encouraged the member to continue sharing such information because it allows us to become familiar with vehicle descriptions and unsafe drivers.

I checked all the river access points and found no issues.

While driving down Keane Drive, I saw a 3-year-old boy walking with his mom. I stopped and let the boy sit in my patrol car's driver's seat so he could see the inside of a patrol car. He was super excited.

I spoke with a member on Regency Circle to see if he was still having problems with a trailer parking on the street. He said it had left.

Sunday 8 a.m.-4 p.m., May 15

I patrolled the neighborhood and completed all 28 listed vacation watch checks. All homes appeared secure.

I noted that William Pond Park now has an on-duty person in the booth at the entrance until 5 p.m. After that, people who want to use the park can pay at the kiosk.

Monday 8 a.m. to 4 p.m., May 16

I patrolled the neighborhood and completed all 21 listed vacation watch checks. All homes

appeared secure.

I monitored student arrivals at Del Dayo Elementary and at Jesuit and Rio Americano High Schools, but observed no problems.

I was dispatched in response to a report of a loud noise in the 4800 block of Paisley Way. Construction crews were reportedly using a saw before 8 a.m. I contacted the complainant and the situation was resolved.

I responded to a report of a night-time package theft in the 3900 block of American River Drive. The suspect was caught on a security camera stealing the package at 3:50 a.m. I took a theft report and obtained pictures of the suspect.

Monday-Tuesday-8 p.m. to 4 a.m., May 16-17

I patrolled the neighborhood and completed all 24 listed vacation watch checks. All homes appeared secure.

It was an uneventful night.

I stopped a woman who was wandering around at the west end of Crondall. A records check revealed that she was on active probation for residential burglary. She admitted that she did not know anyone in the area and told me she was "looking for a trail." I advised her to leave the area and that I would be contacting her probation officer about our interaction.

Tuesday-Wednesday 8 p.m.-4 a.m., May 17-18

I patrolled the neighborhood and completed all 17 listed vacation watch checks. All homes appeared secure.

I responded to an email from a WDDNA member about people parking on lawns on Robin Lane. I drove by to visually see what was occurring. It appeared that Robin Lane is narrow and some residents park portions of their cars on their own lawns so vehicles can more easily get by on the street. I suggested that the member take pictures and email them to county code enforcement to inquire about the legality of the practice.

I responded to an email asking if we could check on a homeless woman sleeping in her car at the entrance to William Pond Park. I checked the area and emailed the homeowner that the woman was gone.

There were no issues at the American River access points.

Thursday 8 a.m.-4 p.m., May 19

I patrolled the neighborhood and completed all 21 listed vacation watch checks. All homes appeared secure.

I responded to a report of a suspicious individual walking on Fair Oaks Boulevard near Del Dayo, but was unable to locate the subject.

I stopped and issued a warning to a driver who did not come to a full stop at the Wycombe and Estates sign.

I cited a vehicle that was parked more than 18 inches from the curb on Estates near Crondall.

Friday 8 a.m.-4 p.m., May 20

I patrolled the neighborhood and completed all 25 listed vacation watch checks. All homes appeared secure.

I assisted patrol with a 911 hang up call from a cell phone in the 700 block of Morris Way. I was unable to locate the caller.

The rest of the shift was quiet.

Sunday 8 a.m.-4 p.m., May 22

I patrolled the neighborhood and completed all 28 listed vacation watch checks. All homes appeared secure.

I issued a warning to a driver who nearly ran a stop sign.

It was getting hot and there were very few dog walkers out after 10 a.m.

Monday-Tuesday-8 p.m. to 4 a.m., May 23-24

I patrolled the neighborhood and completed all 28 listed vacation watch checks. All homes appeared secure.

I responded to an email about a woman seen walking in the area of Jacob and American River Drive earlier in the day. I responded to the area but could not locate the subject.

Another email reported a vehicle parking at the entrance to the William Pond Park river access late in the evening and early in the morning. I randomly drove through the area throughout the night and located a dark blue Toyota Celica with two occupants who do not live in the neighborhood. I advised them of the parking violation and pointed out the numerous no parking signs in the area. Then I sent them on their way.

I responded to a report of a man riding a bicycle erratically on Fair Oaks Boulevard. The complainant said the subject had no lights on the bike, was weaving in and out of traffic and was nearly hit several times by passing vehicles. I located the bicyclist on Fair Oaks Boulevard at Wilhaggin and determined that he was highly intoxicated. I detained him until a CHP officer arrived and subsequently arrested him for DUI.

 Call the Sheriff's Department NON-EMERGENCY LINE at (916) 874-5115. To bypass the recorded messaging when you call, dial 0 after the line is answered.
