# PATROL DEPUTY REPORTS

# Past Two Weeks Reported in Chronological Order

# Tuesday, May 25

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes appeared secure.

Quite a few residents were out walking today. Many were walking in the street, even when a sidewalk was available. Pedestrians should always use sidewalks whenever possible. Many of the streets have blind corners and overgrown bushes limiting visibility and making it dangerous for pedestrians.

I monitored traffic in several areas near the schools but observed no violations.

# Wednesday Day, May 26

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes appeared secure.

I responded to a report of a domestic disturbance in the Selby Ranch complex. A couple was having issues and one decided to leave while I was there.

I was waved down at Estates and American River Drive about a non-injury hit-and-run traffic accident. I was told that two cars were racing eastbound on American River Drive and crashed into each other and then into a parked vehicle. Both of the racing cars fled in different directions, leaving debris in the street. CHP had handled the call.

I responded to a burglar alarm in the 900 block of Somersby Way. It turned out to be false.

I responded to a 911 hang-up call in the 1300 block of Meredith Way. The resident said her cell phone must have dialed by mistake.

It was quiet otherwise.

#### Thursday Day, May 27

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes appeared secure.

I assisted patrol with a burglar alarm which turned out to be false.

I stopped and cited two drivers for failing to stop at the sign at Estates and Wycombe.

# Friday Day, May 28

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes appeared secure.

I monitored the stop sign at Del Dayo Elementary School at the beginning and end of school, but observed no traffic violations.

I responded to two burglar alarms, which were accidental.

I assisted patrol at Rio Americano High School handling the case of a student who reported feeling suicidal. The student was transported to the hospital by the family.

Metro Fire (including its helicopter) responded to a brush fire near the Estates Drive river access. The flames were extinguished by the time I arrived.

# Friday Night, 8 p.m.-4 a.m., May 28-29

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes appeared secure.

Late in the evening, I observed a car stopped on Fair Oaks Boulevard with its flashers on. The woman said her husband was having a medical emergency and needed an ambulance. I called on Metro Fire to respond. The man was transported to a nearby hospital.

The evening was relatively quiet. River access points and the usual hiding spots were empty.

As a point of information: There was a residential burglary around 10 p.m. in the 3000 block of Laurel Drive between Watt Avenue and Munroe in Sierra Oaks. The suspect(s) reportedly broke into the home by smashing a back window and stole a lot of property. The homeowner came home and interrupted the suspect(s), who fled in a white van.

#### Saturday, May 29

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes appeared secure.

The rest of the shift was uneventful.

#### Saturday-Sunday 8 p.m.-4 a.m., May 29-30

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes appeared secure.

I monitored the major intersections. Nothing significant occurred.

#### Monday, May 31

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes appeared secure.

I checked the river access points but observed no issues.

#### Tuesday, June 1

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes appeared secure.

I was waved down by a resident asking questions about disposing of leftover ammunition. I provided her with several options.

I responded to two 911 hang-up calls. Both appeared to be accidental.

I checked the river access points and all were quiet. Ashton Park was busy with many celebrating graduates, but there were no issues.

# Thursday Day, June 3

I assisted patrol with a report of a child who had left Mariemont Elementary after dismissal without waiting for family. The child was located near Starbucks at Arden and Eastern and was reunited with the family.

The rest of the shift was uneventful.

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes appeared secure except one, where a rear slider and a rear door were unlocked. I contacted the owner and secured the home.

I checked the river access roads, but observed no problems. I monitored traffic around Rio Americano High School and Del Dayo Elementary. I saw no violations.

#### Tuesday, June 8

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes appeared secure.

I responded to an email report about a vehicle being gone through by a burglar.

I responded to an alarm on Exmoor. It was false and the resident was home.

I responded to a report that someone had removed a window screen at a home on Dunster. Patrol and I arrived and determined that no entry had been made.

### Wednesday Day, June 9

I patrolled the entire neighborhood and completed all listed vacation watch checks. All homes appeared secure.

I responded to an alarm call in the 3600 block of American River Drive. It was false.

I stopped a resident for driving with an expired license plate registration, but she was able to provide proof that her fee had been paid, so I did not cite her.

I was waved down on McClaren near Arden Way by a man who wanted to know how to file a court request for child visitation. I explained the process.

Otherwise it was a quiet day.
