# **PATROL DEPUTY REPORTS**

## Past Two Weeks Reported in Chronological Order

## Friday-Saturday, 8 p.m.-4 a.m., June 10-11

I patrolled the neighborhood and completed all 30 vacation watch checks. All homes appeared secure.

I checked all river access points and all were clear. There was very little traffic.

I checked a disabled black Dodge (with property stacked all over it) parked on Arden Way near Houseworks. There were three separate calls about it from different residents. The vehicle has a shredded rear tire and does not appear drivable. The two occupants were sleeping when I contacted them. They said they were trying to get someone to help change the tire. I told them I would be back Saturday afternoon and, if they were still there, I would put a 72-hour warning tag on the vehicle.

There was a large teen party in the 1300 block of McClaren Drive that went late into the evening. I monitored it until most of the cars left.

The gates to Rio Americano High School were closed and locked and the lights were off. No one was around all night. Jesuit was quiet also.

## Saturday-Sunday 8 p.m.-4 a.m., June 11-12

I patrolled the neighborhood and completed all 29 vacation watch checks. All homes appeared secure.

I saw four emails about a black van parked on Arden Way near Kingsford Drive. I informed the senders that Deputy Libonati had placed a 72-hour green tag on the car and spoke to the owners.

The rest of the evening was quiet.

## Sunday 8 a.m.-4 p.m., June 12

I patrolled the neighborhood and completed all 36 vacation watch checks. All homes appeared secure.

It was fairly windy all day today. I responded to an alarm that may have been set off by the wind.

I spoke with a motorist and a bicyclist. The motorist said the bicyclist had failed to stop at a stop sign. The cyclist said she did not see the sign. There was no contact or injury in the

incident. I cautioned the cyclist to observe all stop signs.

#### Monday 8 a.m. to 4 p.m., June 13

I patrolled the neighborhood and completed all 32 vacation watch checks. All homes appeared secure.

I checked the parks and gated communities. Traffic was light. The shift was quiet.

#### Monday-Tuesday-8 p.m. to 4 a.m., June 13-14

I patrolled the neighborhood and completed all 32 vacation watch checks. All homes appeared secure.

I came across five or six vehicles and numerous teenagers in the Rio Americano High School parking lot. I directed them to leave and they complied. The main gate had been left open by staff. I contacted the San Juan Unified School District dispatch center to request a key to lock the gate, but they said they had no one available to secure the gate. I checked the school grounds periodically throughout the night.

I located a parked gray Jeep Cherokee in the no-parking area at the William Pond access road. The vehicle was unoccupied and had expired registration tags. I determined that it had been associated with various business burglaries in the area. I issued a parking citation and spoke to the owner, who showed up just as I was completing the citation. I advised him of the no-parking signs and that his registration was expired. He then drove away.

I contacted six or seven juveniles in Ashton Park, told them that the park was closed and that they should leave, which they did.

#### Tuesday-Wednesday 8 p.m.-4 a.m., June 14-15

I patrolled the neighborhood and completed all 35 vacation watch checks. All homes appeared secure.

I checked on the black van that had been parked at Arden Way and Kingsford Drive. It was gone.

At 12:47 a.m. I saw a vehicle driving westbound on Fair Oaks Boulevard around Jacob Lane at 100-plus mph. I stopped the car. The 20-year-old driver had no valid license and had a blood-alcohol reading above twice the legal limit. I arrested him and had his vehicle impounded.

Otherwise, it was a quiet night. However, I did see several animals around the neighborhood, including deer, a grey fox, a coyote and rabbits.

#### Thursday 8 a.m.-4 p.m., June 16

I patrolled the neighborhood and completed all 34 vacation watch checks. All homes appeared secure.

I assisted patrol in establishing a perimeter for a Placer County felony burglary suspect who had run from officers near Fair Oaks Boulevard. The subject could not be located.

#### Monday 8 a.m. to 4 p.m., June 20

I patrolled the neighborhood and completed all 26 vacation watch checks. All homes appeared secure.

I responded to burglar alarm in the 4800 block of Finlandia Way. It was cancelled before I arrived.

Traffic was light today and the rest of the shift was quiet.

#### Monday-Tuesday-8 p.m. to 4 a.m., June 20-21

I patrolled the neighborhood and completed all 26 vacation watch checks. All homes appeared secure.

I assisted an officer with a possible residential burglary in progress off of Oak Avenue, north of the Del Dayo area. When we contacted the resident, he said he had accidentally left doors open earlier in the night.

The California Highway Patrol was working a fatal hit-and-run accident on Fair Oaks Boulevard at El Camino. The vehicle was last seen driving south on Fair Oaks, so I checked areas around Wilhaggin in case the suspect had dumped the vehicle. The search was negative.

I responded to a report of loud music on Dovercourt Circle. When I arrived, I heard what sounded like a party going on in the garage. I contacted the woman tenant and advised her to turn down the music and to take the group inside the home. She complied.

#### Tuesday-Wednesday 8 p.m.-4 a.m., June 21-22

I patrolled the neighborhood and completed all 21 vacation watch checks. All homes appeared secure.

At 6:45 p.m. I responded to a report of a transient possibly setting up camp near Saverien Drive and Fair Oaks Boulevard. I checked all the bushes along Fair Oaks, but did not find the transient. I contacted the homeowner to advise him of the situation.

I received an email from a resident who wanted to report that a car had been left parked on Kevington Court. The vehicle had been damaged in an accident and was inoperable. According to the email, the driver had advised them they would get the car towed. I found the car, placed a green 72-hour notice on the window and advised the homeowners that if the car was not moved by Friday, I would take care of it during my Saturday night shift.

I checked all the river access points and all were quiet.

#### Wednesday 8 a.m.-4 p.m., June 22

I patrolled the neighborhood and completed all 20 vacation watch checks. All homes appeared secure.

I responded to an alarm call in the 4200 block of Guildford Court. It was false.

I responded to the 5500 block of Susan Way to take a forgery report. The homeowner said she had mailed a couple of checks that apparently were then stolen out of her mailbox. The thief had washed the checks and added a different payee, then tried to cash them at a check cashing business. However, the check cashing business called the resident and the checks were not cashed. The suspect reportedly used her own name, so there is a chance she will be caught.

The rest of the sift was quiet.

#### IN AN EMERGENCY

If you have an immediate emergency - if your life or property is in immediate danger, if you feel threatened by someone on or near your property, if you have just become the victim of a crime or if you are witnessing a crime in progress:

- CALL 911 from a land line.
- Or, if calling from a cell phone within Sacramento County, call (916) 874-5111.

## TO REPORT A CRIME

There are two ways to report a crime to the Sacramento County Sheriff's Department:

- 1. Call the Sheriff's Department NON-EMERGENCY LINE at (916) 874-5115. To bypass the recorded messaging when you call, dial 0 after the line is answered.
