# PATROL DEPUTY REPORTS

# Past Two Weeks Reported in Chronological Order

### Friday Night, 7 p.m.-3 a.m., June 25-26

I patrolled the neighborhood and completed all listed vacation watch checks. All homes appeared secure.

I issued a warning to a motorist for driving at night with no headlights near Estates Drive and Fair Oaks Boulevard.

I responded to a report of a person in the 500 block of Wilhaggin Drive who rang a doorbell, then ran away. I arrived within minutes, but did not see anyone.

I cited a driver for a registration violation near Fair Oaks Boulevard and Arden Way.

I encountered a man in a vehicle in a parking lot on Fair Oaks Boulevard. He said he was changing his car's oil. He checked clear and left the area.

I encountered several juveniles in the swimming pool at Rio Americano High School and had them leave.

I responded to a burglar alarm activated by a person who did not have the correct alarm code. The person checked out.

I assisted patrol with a report of teenager who flew into a rage after his parents discovered marijuana and removed it. I spoke with the teen and gave him advice about life choices. He was calm and seemed sorry for his behavior.

I responded to a report of a 911 hang-up near Rio Americano High School. I checked the area, but was unable to find the caller.
