

# Monday 8 a.m. to 4 p.m., June 26

and was safe.

I patrolled the neighborhood and completed all 38 listed vacation watch checks. All homes were secure.

Lots of people out and about enjoying the nice weather.

I met with a homeowner in the 3600 block of Fair Oaks Boulevard who was a recent victim of a residential burglary. He said his house is back in order and that he had obtained a restraining order against the suspect.

I responded to a report that several juveniles were driving a silver Mercedes erratically in the 1200 block of Los Rios Drive and yelled at a gardener. I checked the area, but could not located them.

#### Tuesday 8 a.m. to 4 p.m., June 27

I patrolled the neighborhood and completed all 32 listed vacation watch checks. All homes were secure.

I responded to a report of two men seen riding bicycles westbound on Fair Oaks Boulevard. The reporting party thought they might be the subjects recently suspected of burglaries. I was able to locate the men. One had a bike pulling a small open trailer. Both men checked clear of warrants. One was on probation. I checked the trailer, which had no evidence of stolen items. The men were cooperative and I released them after obtaining their information.

I met with a WDDNA member in the 3900 block of Crondall Drive. She was concerned about homeless camps located on the south side of the levee. Although the site is outside the WDDNA patrol area and under the jurisdiction of park rangers, I met with Ranger Duggins and drove to the area she described. We found two homeless camps deep in the brush. One was abandoned, the other unoccupied at that time. Duggins said he would initiate the cleanup of the abandoned camp and would begin an eviction process for the second camp. I spoke to the WDDNA member and relayed the ranger's information.

#### Wednesday 8 a.m.-4 p.m., June 28

I patrolled the neighborhood and completed all 31 listed vacation watch checks. All homes were secure.

I responded to the 3600 block of American River Drive where a subject was seen checking car doors in the parking lot. He was gone when I arrived.

A resident waved me down to report that three men were going door to door. I located the men on Exmoor Circle. They said they were from the Victory Outreach program and were doing curb address painting to raise money. I advised them about the requirement to obtain a county solicitor's permit for residential soliciting. All three checked clear and left the area.

#### Wednesday 4-10 p.m., June 28

I patrolled the neighborhood and completed all 31 listed vacation watch checks. All homes were secure.

I monitored traffic at Estates and American River Drive, Jacob and Keane, Los Rios and American River Drive, and McClaren and Arden. I stopped one driver for a stop sign violation and issued a warning.

I parked at Rio Americano High School, Del Dayo Elementary School and Ashton Park for some high visibility security.

I checked the river access points and all were quiet.

## Thursday 8 a.m.-4 p.m., June 29

I patrolled the neighborhood and completed all 33 listed vacation watch checks. All homes were secure.

I did not observe any vehicle code violations while on patrol. I did see several groups of high school age young people jogging in the neighborhood, likely as part of some sports program.

The rest of the shift was quiet.

## Sunday 8 a.m.-4 p.m., July 2

I patrolled the neighborhood and completed all 52 listed vacation watch checks. All homes

were secure.

I monitored several intersections but observed no traffic violations. There was very heavy pedestrian traffic all day long.

I spoke to several of the pedestrians and was advised of a driver asleep in a green Dodge Ram truck parked at the intersection of American River Drive and Estates Drive. I responded to the location but was unable to locate the subject or vehicle.

#### Monday 8 a.m. to 4 p.m., July 3

I patrolled the neighborhood and completed all 48 listed vacation watch checks. All homes were secure.

Today was another warm day with lots of people out and about.

I responded to a report of a man on a bike who appeared to be under the influence and who had run into a parked car. The subject was last seen riding eastbound on American River Drive at Watt Avenue. I began checking the area and was hailed by a subject in a pickup truck in the 3600 block of American River Drive, who said the subject was lying nearby in some ivy. I found the man, who appeared to be in pain and had multiple bloody abrasions on his face, arms and hands. He told me he had been bit by a car, however, the witness disputed that. Metro fire and a CHP unit arrived and the subject agreed to go to the hospital.

#### Tuesday 8 a.m. to 4 p.m., July 4

I patrolled the neighborhood and completed all 50 listed vacation watch checks. All homes were secure.

It was busy in the morning with people out and about, including the bike trail access points and Aston Park.

I made note of a report by a Crondall Drive resident who said an unknown person with a backpack had knocked on his door. I patrolled Crondall Drive several times looking for anyone matching the security photo he provided, but did not see him.

A resident waved me down to report seeing a person in a white Ford Fiesta who was parked across from her house on Chancery Way on several occasions. She provided the license plate number, which was registered to an address outside the neighborhood. The driver appeared to be a woman, approximately 50 years old, heavy set with gray hair.

I patrolled the 3600 block of Fair Oaks Boulevard, where a residential burglary occurred on June 18. I observed no suspicious people or vehicles.

#### Wednesday 8 a.m.-4 p.m., July 5

I patrolled the neighborhood and completed all 41 listed vacation watch checks. All homes were secure.

I was waved down by a couple on Eastern Avenue who had just seen and recorded a video of a man in a car spinning donuts in a local park. They said the driver had confronted them. I checked the area, but he was gone. However, I was able to get his license plate from the video and determined that he lived nearby. I went to his house along with another patrol unit and contacted the subject, who appeared intoxicated and uncooperative. We contacted the original reporting party and, with his permission, transported him to our location to identify the driver. We had already contacted CHP and they responded. The reporting party made a positive identification of the driver, so CHP conducted a DUI evaluation and arrested him for DUI.

#### Wednesday 4-10 p.m., July 5

I patrolled the neighborhood and completed all 40 listed vacation watch checks. All homes were secure.

I monitored traffic at the intersections of Wilhaggin and American River Drive, Estates and American River Drive, McClaren and Shelato, and Guilford and Ashton. I observed no traffic violations.

I parked at Rio Americano High School, Del Dayo Elementary School and Ashton Park for some high visibility security.

#### Thursday 8 a.m.-4 p.m., July 6

I patrolled the neighborhood and completed all 42 listed vacation watch checks. All homes were secure.

I assisted patrol with an alarm call near the Sheriff's Academy. It was determined to be false.

As I was going off duty, a member on Ashton Drive emailed to report that someone had drilled a hole in his gas tank and removed all the gas. I advised him to report the crime online at https://www.sacsheriff.com.

#### Saturday, 4-10 p.m., July 8

I patrolled the neighborhood and completed all 35 listed vacation watch checks. All homes were secure.

I responded to a report of a person – a possible transient – acting strange at American River Drive and Thornley Way. I located the man about a block away. I determined that he had committed no crimes and was not intoxicated. He had no outstanding warrants and was known to hang out near the river and Rancho Cordova. I offered him a ride out of the area, but he declined. I watched him for a while and he eventually walked south on Watt Avenue towards Rancho Cordova.

All the river access points checked clear.

#### Sunday 8 a.m.-4 p.m., July 9

I patrolled the neighborhood and completed all 39 listed vacation watch checks. All homes were secure.

I assisted patrol responding to two calls for service on Keane Drive where a resident was having problems with an ex-girlfriend who kept trying to sneak into his home. In both cases, the ex-girlfriend was gone when we arrived.

I assisted patrol with one incident outside the neighborhood at a nearby apartment complex where an armed individual was reportedly waving a gun around. The subject was eventually detained, a firearm was recovered and the subject was arrested and booked by patrol deputies.

I monitored several intersections, stopped two drivers for violations and issued verbal warnings.

- CALL 911 from a land line.
- Or, if calling from a cell phone within Sacramento County, call (916) 874-5111.

# **TO REPORT A CRIME**

There are two ways to report a crime to the Sacramento County Sheriff's Department:

- 1. Call the Sheriff's Department NON-EMERGENCY LINE at (916) 874-5115. To bypass the recorded messaging when you call, dial 0 after the line is answered.
