



Twice-Monthly Patrol Report filed by WDDNA's Off-Duty Sheriff's Deputies

## PATROL DEPUTY REPORTS

Past Two Weeks Reported in Chronological Order

### **Saturday 8 a.m.-4 p.m., July 9**

I patrolled the neighborhood and completed all 36 listed vacation watch checks. All homes appeared secure.

The shift was extremely quiet. There was very little vehicular or foot traffic.

### **Monday 8 a.m. to 4 p.m., July 11**

I patrolled the neighborhood and completed all 28 listed vacation watch checks. All homes appeared secure.

I responded to an email from a resident on Wyndgate Road who reported seeing an unknown man walking around the neighborhood in a way that suggested he was casing the area. The resident contacted the man and sent him away before I arrived.

The rest of the shift was quiet.

### **Monday-Tuesday-8 p.m. to 4 a.m., July 11-12**

I patrolled the neighborhood and completed all 28 listed vacation watch checks. All homes appeared secure.

During the night, I had several drivers leave the area when I found them parked at the entrance to William Pond Park.

At approximately 2 a.m., I assisted patrol searching for a missing female dementia patient. She still had not been located by the time my shift ended.

It was otherwise a quiet shift.

### **Tuesday-Wednesday 8 p.m.-4 a.m., July 12-13**

I patrolled the neighborhood and completed all 26 listed vacation watch checks. All homes appeared secure. I moved one large package to a backyard and emailed the homeowners about it.

I checked all the river access points, but observed no problems.

### **Friday 8 a.m.-4 p.m., July 15**

I patrolled the neighborhood and completed all 25 listed vacation watch checks. All homes appeared secure.

I responded to a burglar alarm on Glen Aulin Court. It appeared to be false.

Otherwise, the shift was extremely quiet.

**Sunday 8 a.m.-4 p.m., July 17**

I patrolled the neighborhood and completed all 30 listed vacation watch checks. All homes appeared secure.

At one of the homes I found a full soda drink, with lid and straw and a plastic bag, apparently with food in it. It was sitting on the porch right in front of the front door. The residence was otherwise locked and nothing appeared to be disturbed or tampered with. No one answered when I knocked, so I contacted the local person referenced in the vacation watch request and left a message. I also left a message for the homeowner, who called me back. She said she had no one staying at her home who would be expecting a food delivery. She assumed a delivery person had gotten the wrong address.

I stopped a driver for running a stop sign right in front of me. He told me he had just gotten off work and was on his way to walk someone's dog for them. I issued a warning for the violation.

The rest of the shift was quiet.

**Monday 8 a.m. to 4 p.m., July 18**

I patrolled the neighborhood and completed all 28 listed vacation watch checks. All homes appeared secure.

I responded to a report of a suspicious vehicle with a large trailer parked in the 1100 block of Jacob Lane. It was gone when I arrived.

It was a very hot day with very few people out and about.

**Monday-Tuesday-8 p.m. to 4 a.m., July 18-19**

I patrolled the neighborhood and completed all 30 listed vacation watch checks. All homes appeared secure.

There was very little pedestrian or vehicle traffic.

I responded to an email about a homeless man sleeping at night in the bushes behind a generator on Arden Way near Gregory Way. I contacted the man, advised him to leave and provided him with homeless assistance information through county 211. The subject left the area without incident.

I checked on a black Cadillac Escalade SUV parked on American River Drive near Tennyson. A man was sleeping in the driver seat. He told me that the car was broken down with a flat tire and he was waiting for a tow truck. I checked 20 minutes later and the tow truck was assisting him.

I assisted patrol with a report of an armed subject selling drugs in the parking lot of a nearby store. I arrived on scene and helped detain the subject, who was indeed armed. He was arrested and booked by patrol.

I assisted patrol responding to a report that a subject was throwing bottles at passing cars around Watt Avenue and Fair Oaks Boulevard. The subject was gone upon my arrival.

I contacted a small group of juveniles in Ashton Park in the early morning hours and advised them that the park was closed. They left the area without incident.

**Tuesday-Wednesday 8 p.m.-4 a.m., July 19-20**

I patrolled the neighborhood and completed all 24 listed vacation watch checks. All homes appeared secure.

There were no issues at the river access points. It was a quiet shift.

**Friday-Saturday, 8 p.m.-4 a.m., July 22-23**

I patrolled the neighborhood and completed all 34 listed vacation watch checks. All homes appeared secure.

I responded to a report that a bicycle had been left in the yard of a resident on Grovesnor Court for about a month. I booked the bike as found property at the North Area Station.

The rest of the shift was quiet.

**Saturday 8 a.m.-4 p.m., July 23**

I patrolled the neighborhood and completed all 28 listed vacation watch checks. All homes appeared secure. I emailed two homeowners to let them know they had packages delivered on their porches.

There were no issues at the river access points. It was a very quiet day.

**Sunday 8 a.m.-4 p.m., July 24**

I patrolled the neighborhood and completed all 33 listed vacation watch checks. All homes appeared secure. I was removing two large boxes on Elsdon to put them out of sight when the neighbor came over and accepted them for the resident.

Dog walkers were all out early. It was a quiet afternoon.

### **IN AN EMERGENCY**

If you have an immediate emergency - if your life or property is in immediate danger, if you feel threatened by someone on or near your property, if you have just become the victim of a crime or if you are witnessing a crime in progress:

- CALL 911 from a land line.
- Or, if calling from a cell phone within Sacramento County, call (916) 874-5111.

### **TO REPORT A CRIME**

There are two ways to report a crime to the Sacramento County Sheriff's Department:

1. Call the Sheriff's Department NON-EMERGENCY LINE at (916) 874-5115. To bypass the recorded messaging when you call, dial 0 after the line is answered.
