# PATROL DEPUTY REPORTS

Past Two Weeks Reported in Chronological Order

#### Monday 8 a.m. to 4 p.m., July 25

I patrolled the neighborhood and completed all 28 scheduled vacation watch checks. All homes appeared secure

I checked the river accesses and parks and all were quiet.

I received an email about two loose dogs near the intersection of Keane and Kipling. After checking the area, I was unable to locate them.

# Monday-Tuesday-8 p.m. to 4 a.m., July 25-26

I patrolled the neighborhood and completed all 30 scheduled vacation watch checks. All homes appeared secure

At 10:30 p.m. I observed a blue pickup truck at the locked entrance for William Pond river access. A man was sleeping inside and appeared to be a transient. I advised him that he was parked in a no-parking zone and that he could not sleep there. He drove away without any incident.

At 11:20 p.m. I found the main gate at Rio Americano High School had been left open, so I locked it.

At 12:30 a.m. I contacted a small group of juveniles in the playground area at Ashton Park. I told them that the park was closed and they had to leave, which they did.

# Tuesday 8 a.m. to 4 p.m., July 16

I patrolled the neighborhood and completed all 28 scheduled vacation watch checks. All homes appeared secure

At 1:34 a.m. I received an email from a homeowner that the Rio Americano High School gate had been left open and kids were doing donuts in the parking lot. I responded and arrived in less than three minutes, but observed no vehicles in the lot, so I locked the gate.

The rest of the night was very guiet.

# Thursday 8 a.m.-4 p.m., July 28

I patrolled the neighborhood and completed all 32 scheduled vacation watch checks. All homes appeared secure

I observed an open garage door in the 4700 block of Marlborough. There was no answer at the door, so I closed the garage door and contacted the homeowner about the incident.

A member emailed me to report that someone had dumped two garbage bags of horse manure onto Gordon Lane around 2 p.m. on Sunday. The vehicle reportedly was a maroon SUV.

The rest of the shift was quiet.

# Friday-Saturday, 8 p.m.-4 a.m., July 29-30

I patrolled the neighborhood and completed all 25 scheduled vacation watch checks. All homes appeared secure

I responded to a burglar alarm on Harrington. The homeowner reported that the alarm was activated by accident.

I observed an open garage door on McClaren Drive. I alerted the homeowner, who thanked me for letting him know.

A resident contacted me to report that a neighbor's vehicle was parked on the sidewalk. I went to the house, but no one answered the door. I told the reporting person to alert the department's parking enforcement office if the situation continued.

I observed an unoccupied vehicle with its hazard lights flashing at the corner of Jacob Lane and American River Drive. I spoke to a homeowner where the vehicle was parked. She told me that an elderly woman had stopped there due to engine problems, had gotten a ride home and said she would pick the vehicle up later. I checked a couple of hours later and saw the vehicle being fixed and driven out of the area.

The rest of the shift was quiet.

#### Monday 8 a.m. to 4 p.m., Aug. 1

I patrolled the neighborhood and completed all 23 scheduled vacation watch checks. All homes appeared secure

All parks and river accesses were clear and there were no calls for service.

#### Tuesday-Wednesday 8 p.m.-4 a.m., Aug. 2-3

I patrolled the neighborhood and completed all 18 scheduled vacation watch checks. All homes appeared secure

I responded to an email that was sent Monday night about teenagers setting off fireworks in the Del Dayo Elementary School parking lot.

At 11 p.m. I saw an open garage door on Chancery Way and alerted the homeowner.

Due to recent car burglary activity in the area of Shelato and Los Rios, I spent extra time patrolling there. I observed no concerning activity.

#### Wednesday 8 a.m.-4 p.m., Aug. 3

I patrolled the neighborhood and completed all 20 scheduled vacation watch checks. All homes appeared secure

It was very hot today and few residents were outside. In response to homeowner requests, I cruised Claydon Way, Greywell Way and Chilham Way multiple times.

I responded to the 1200 block of Lantern Court where the homeowner's adult daughter

said she had been assaulted by her ex-boyfriend in her home in the city of Sacramento. The mother said she had received threatening texts from the man, as well. I took a report about the threats and suggested that the daughter report the assault to the Sacramento Police Department.

# Friday 8 a.m.-4 p.m., Aug. 5

I patrolled the neighborhood and completed all 24 scheduled vacation watch checks. All homes appeared secure

The shift was extremely quiet.

# Friday-Saturday, 8 p.m.-4 a.m., Aug. 5-6

I patrolled the neighborhood and completed all 23 scheduled vacation watch checks. All homes appeared secure

When I came on duty, there was a unit already on scene in the 400 block of Boston Court taking a burglary report. A burglar had entered an unsecured rear yard Thursday night and removed property.

The gates to Rio Americano High School were open, so I had to get teens to leave the campus over the course of my shift.

I responded to a burglar alarm call in the 3800 block of Dunster and found the front door unlocked. After a search, nothing appeared out of place. I secured the home and contacted the owner, who was out of town.

I responded to a panic alarm in the 1300 block of Gary Way. I determined that the resident was OK.

#### Saturday 8 a.m.-4 p.m., Aug. 6

I patrolled the neighborhood and completed all 28 scheduled vacation watch checks. All homes appeared secure

I was dispatched to a home in the 4800 block of American River Drive, where a woman was concerned that she may have been followed home by an older white Toyota Camry with a partial license plate of "8DL." The area checked clear for the vehicle.

#### Saturday-Sunday 4-10 p.m., Aug. 6

I patrolled the neighborhood and completed all 27 scheduled vacation watch checks. All homes appeared secure

Around 8 p.m. I checked on a blue Ford Escape in front of Rio Americano High School that a nearby homeowner had reported as possibly being abandoned. The car was currently registered but appeared dusty and had cobwebs on the tires. I did a records search and found that the vehicle appeared to belong to a local transient who has been known to stay in the Rancho Cordova area. I placed a green sticker on the driver side window to warn the owner that he had 72 hours to move the car or it would be towed.

As I patrolled, I stopped to give several children stickers and speak with their parents.

#### Sunday 8 a.m.-4 p.m., Aug. 7

I patrolled the neighborhood and completed all 14 scheduled vacation watch checks. All homes appeared secure

I responded to a report of an incomplete 911 call from a cell phone on American River Drive. I drove the full length of the street, but observed no one who appeared to need assistance. I went to the address associated with the call, but no one was there.

I was stopped by two women out walking who said they noticed a "pungent smell" coming from behind shrubs on Arden Way near Kingsford. They thought a homeless person may have been behind the shrubs. I checked the area, but did not find anyone. I later responded to another homeowner who reported seeing a homeless person hanging around his house in the general area of Arden Way and Kingsford. Again, I did not locate anyone. Whoever it is may be jumping a fence into a back yard.

I responded to Lake Wilhaggin where residents said two juveniles had insisted on fishing in the small lake there. I spoke to a resident who said he had seen the pair, determined that they did not live there and told them they could not fish. He said no further assistance was needed.

It was otherwise a quiet day.

# Monday 8 a.m. to 4 p.m., Aug. 8

I patrolled the neighborhood and completed all 28 scheduled vacation watch checks. All homes appeared secure

I was dispatched to a burglar alarm in the 500 block of Estates Drive. The alarm company indicated that a side garage door sensor had been activated. I found the residents at home and was told that they had set off the alarm accidentally.

I checked all the river access points and all were clear.

# Monday-Tuesday-8 p.m. to 4 a.m., Aug. 8-9

I patrolled the neighborhood and completed all 28 scheduled vacation watch checks. All homes appeared secure

I checked the area around Shelato Way and Los Rios multiple times, but observed no suspicious activity.

I responded to an email about a transient who has been sleeping by an AT&T box on Arden Way near Kingsford Way. I drove the area multiple times but was unable to locate anyone sleeping there.

I contacted numerous juveniles walking around the area near Rio Americano High School and Ashton Park. There were two reports of loud juvenile activity. The issue mainly involved a group of approximately 40 teens who were driving around in their vehicles looking for a place to party. I was able to make most of them leave the area. They initially gathered at Ashton Park and then Rio, but I cleared them out.

A resident reported possible gunfire in the area of Arden Way and McClaren. I responded to the area but was unable to find anything out of the ordinary.

#### Tuesday-Wednesday 8 p.m.-4 a.m., Aug. 9-10

I patrolled the neighborhood and completed all 24 scheduled vacation watch checks. All homes appeared secure

I followed up with a car that had been reported abandoned in front of Rio Americano High School. On Saturday, I had issued a 72-hour notice to move it. It was still there this evening, so I had it towed.

Rio's gates were locked by 10 p.m. and there were no issues at the river access points.

I patrolled the Los Rios/Shelato area between 2:30 and 3:30 a.m. All was quiet.

- 1. Call the Sheriff's Department NON-EMERGENCY LINE at (916) 874-5115. To bypass the recorded messaging when you call, dial 0 after the line is answered.
