

Twice-Monthly Patrol Report filed by WDDNA's Off-Duty Sheriff's Deputies

PATROL DEPUTY REPORTS

Past Two Weeks Reported in Chronological Order

Tuesday-Wednesday 10 p.m.-4 a.m., Aug. 24-25

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I responded to an email from a resident asking about a vehicle that had been parked and covered on the street for several days. I responded that the car was registered to that address. I asked the day-shift patrol to contact the car's owner with information about parking rules.

Thursday Day, Aug. 26

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I assisted patrol with an incomplete 911 call near American River Drive and Watt Avenue. It was a misdial. I monitored traffic on Crondall near Estates after Rio Americano High School let out. I cited a driver for speeding and failure to stop completely at a stop sign.

The rest of the shift was quiet.

Friday Day, Aug. 27

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I monitored the stop sign at American River Drive and Estates Drive, but observed no traffic violations.

While monitoring the stop sign at American River Drive and Ashton Drive, I was approached by a resident who reported that there were early morning speeders on the street Monday through Friday.

While patrolling near Rio Americano High School, I contacted a student who was sitting on the sidewalk in front of a home on Saverien Drive. I asked him if he was okay and why he wasn't in school. I determined that he was waiting for a ride to a dental appointment.

The rest of the shift was quiet.

Monday, Aug. 30

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I observed no problems on the streets during my shift. All was quiet.

Tuesday, Aug. 31

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

While patrolling, I paid extra attention to the areas around the schools during drop-off and pick-up times.

Numerous pedestrians were out today. Traffic was moderate.

Tuesday-Wednesday 10 p.m.-4 a.m., Aug. 31-Sept. 1

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I responded to an email related to a homeowner's deceased cat. There was no foot traffic and very little traffic this evening.

Wednesday Day, Sept. 1

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I came upon an older van with no front license plate parked on Lake Oak Court. I contacted the two occupants (a husband and wife) who run an appliance repair business. They said they were waiting for the homeowner to let them into the gated residential area. The driver checked clear.

I monitored activity around Rio Americano High School and Del Dayo Elementary School while they were in session.

I assisted patrol with the arrest of a man on a felony warrant after he was stopped while driving his vehicle onto Watt Avenue from Highway 50. The man was arrested and transported back to the Bay Area by Berkeley PD.

I came upon an accident on Eastern Avenue where a solo vehicle had flipped over and was lying upside down on a resident's front lawn. The driver was extricated and transported to a local hospital. CHP handled the crash.

Thursday Day, Sept. 2

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I monitored traffic on Crondall near Estates before and after Rio Americano High School started and let out for the day. I cited two drivers for speeding and failing to come to a full stop at the stop sign.

The rest of the shift was quiet.

Friday Day, Sept. 3

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I learned that problems had been reported involving Jesuit High School students and parents driving erratically on American River Drive after school. I monitored the intersection at Jacob Lane and American River Drive during dismissal time as a deterrent.

I also monitored Del Dayo Elementary School and several intersections for traffic violations, but observed none.

Friday Night, 7 p.m.-3 a.m., Sept. 3-4

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I located a transient lying in the bushes in the 3600 block of Fair Oaks Boulevard. He was charging his cell phone and reading a magazine. I had him leave.

I responded to a report of a naked Asian male waiving down cars on American River Drive under Watt Avenue. After an exhaustive search, patrol and I located him at the 76 Gas Station at Watt Avenue and Fair Oaks Boulevard. He was naked and all wet. He claimed that he was suicidal and decided to end it all by jumping into the American River off the Watt Avenue Bridge, which he did. But on the way down, he apparently changed his mind. Somehow, he climbed out of the river with only minor injuries and tried to flag down cars. He said he could not understand why drivers would not stop in the middle of the night to help a wet naked man who was chasing cars and screaming in a foreign language. He was taken to a local hospital on a mental-health hold.

Around 2:30 a.m., I stopped a car that was driving slowly near Harrington and McClaren Drive. It was a full of local teenagers. The driver was trying to quietly drop off one of the passengers so the young man could get into his house without waking his parents. The teens were cooperative and I sent them all home.

Saturday, Sept. 4

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I spoke with a resident and provided some information about code enforcement. I stopped two people at Ashton Park and advised them of leash requirements.

I contacted two carloads of teens in the parking lot at Rio Americano High School and advised them to move along.

The rest of the shift was quiet.

Sunday, Sept. 5

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I spoke with two residents in one of the gated communities and answered questions. I parked at a few major intersections and watched for violations, but observed none. I checked all the river access points and they were all quiet.

Monday, Sept. 6

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I responded to a burglar alarm on Kingsford. It was false.

I was dispatched to American River Drive near Tennyson Drive. Several parents had parked their cars on the side of American River Drive while their sons were running Cross Country from Jesuit High School. Two subjects in a white Nissan Altima had reportedly driven by and thrown eggs at several of the parked cars. Bystanders and car owners washed the eggs off the cars and I finished cleaning one car. None of the vehicles were damaged and all the owners were contacted. During the rest of my shift, I looked for the Altima, but did not spot it. There were no other reported incidents.

Tuesday, Sept. 7

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I responded to a 911 hang-up call near Rio Americana High School, but could not locate the caller.

I monitored several intersections, but observed no traffic violations.

Tuesday-Wednesday 10 p.m.-4 a.m., Sept. 7-8

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I was dispatched to the Arden Oaks neighborhood in response to an officer-involved shooting. The officer will be OK. When the scene was stable, I returned my patrol duties.

I responded to an email from a WDDNA member to check on her home. All was normal.

Around midnight I noticed a car parked in a driveway on Treeside Drive with its door left wide open. I checked with the homeowner to determine whether it had been left open accidentally or if a crime may have occurred. He said it was accidentally left open

Wednesday Day, Sept. 8

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

The shift was quiet.

Thursday Day, Sept. 9

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I assisted patrol with an audible alarm on Gary Way. It was false.

I monitored traffic on Crondall near Estates after Rio Americano High School let out for the day. I cited one driver for failing to fully stop at the stop sign.

I assisted patrol responding to a report of a man on a bike looking at houses near Fair Oaks Boulevard. We were unable to locate the subject.

The rest of the shift was quiet

Or, if calling from a cell phone within Sacramento County, call (916) 874-5111.

TO REPORT A CRIME

There are two ways to report a crime to the Sacramento County Sheriff's Department: 1. Call the Sheriff's Department NON-EMERGENCY LINE at (916) 874-5115. To bypass the recorded messaging when you call, dial 0 after the line is answered.
