

Twice-Monthly Patrol Report filed by WDDNA's Off-Duty Sheriff's Deputies

PATROL DEPUTY REPORTS

Past Two Weeks Reported in Chronological Order

Monday, Sept. 13

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

There was an email from a resident on Whitehall who was concerned about parents parking on American River Drive between Whitehall and Rio Americano High School after school. I drove by Rio Americano High School several times when students were released, but observed no parking issues.

I responded to one burglar alarm. The resident showed up while I was on scene and said she had accidentally set the alarm incorrectly.

Tuesday, Sept. 14

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I monitored stop signs during school dismissal times, but observed no traffic violations.

I saw a person hide behind a tree as I turned the corner to Kevington Court. As I made a U-turn, he walked down Fair Oaks Boulevard. I checked on him and determined that he is a tenant in the neighborhood.

I responded to a resident on Lantern Court who said she had seen a subject sweeping the street with a branch, but that he had left before I arrived.

I responded to a report from a mail carrier who had seen a vehicle that appeared to have been broken into in the 1300 block of Kingsford. I located the vehicle, which had a broken window. The interior did not appear to be ransacked. I contacted the owner, who said nothing appeared to be missing.

I monitored several stop signs along American River Drive, but observed no traffic violations. Drivers appeared to slow down when they saw my vehicle.

Wednesday Day, Sept. 22

I patrolled the neighborhood and completed all listed vacation watch checks. All homes were secure.

I stopped four drivers at American River Drive and Wilhaggin for stop sign violations. All were apologetic and admitted to the violation. I released them with warnings.

I responded to a report of a suspicious subject, but he was gone when I arrived.

I stopped a driver at American River Drive and Estates for having an inoperable brake light and urged her to get it fixed.

I monitored traffic during dismissal time at Rio Americano High School, but observed no violations.

TO REPORT A CRIME

There are two ways to report a crime to the Sacramento County Sheriff's Department:

- 1. Call the Sheriff's Department NON-EMERGENCY LINE at (916) 874-5115. To bypass the recorded messaging when you call, dial 0 after the line is answered.
