# PATROL DEPUTY REPORTS

Past Two Weeks Reported in Chronological Order

## Monday 8 a.m. to 4 p.m., Sept. 12

I patrolled the neighborhood and completed all 27 listed vacation watch checks. All homes were secure.

All parks and river access areas checked clear of any suspicious subjects or vehicles.

## Wednesday 8 a.m.-4 p.m., Sept. 14

I patrolled the neighborhood and completed all 24 listed vacation watch checks. All homes were secure.

School was in session, but I saw no traffic violations. I observed no transients in the area.

I stopped a driver near Fair Oaks Boulevard and Saverien for having an expired registration. The driver said when she refinanced her car she changed insurance carriers and her bank sent the title to the wrong insurance company. She had several documents to support her story, so I did not cite her.

## Friday 8 a.m.-4 p.m., Sept. 16

I patrolled the neighborhood and completed all 31 listed vacation watch checks. All homes were secure.

I responded to an alarm at a business in the 3400 block of American River Drive. There was no issue.

I monitored traffic at the high school and elementary school. There were no traffic violations.

I responded to a grass fire on the American River Parkway behind Ashton Drive and North River Way. Sacramento Metro Fire had it under control and arson investigators will be looking into it. It did not appear to be a homeless issue.

#### Friday-Saturday, 8 p.m.-4 a.m., Sept. 16-17

I patrolled the neighborhood and completed all 27 listed vacation watch checks. All homes were secure.

I was waved down by a resident about a male transient near Fair Oaks Boulevard and San Lucas Way. I located him. He was a 45-year-old man with a towel over his head who was talking to himself and pushing a shopping cart. He was cooperative and said he was

lost and looking for the river. He checked clear, so I pointed the way and off he went.

I cited a driver for a stop sign violation at American River Drive and Wilhaggin Drive.

I responded to a report of an unoccupied vehicle in the 4500 block of American River Drive. It was gone when I arrived.

The schools were quiet and all the river access points were empty.

## Saturday, 8 a.m. – 4 p.m., Sept. 17

I patrolled the neighborhood and completed all 28 listed vacation watch checks. All homes were secure.

The shift was quiet with very little vehicular or foot traffic.

## Saturday 4-10 p.m., Sept. 17

I patrolled the neighborhood and completed all 24 listed vacation watch checks. All homes were secure.

The weather cooled down today and it was nice to see many people walking around, riding bikes with their kids and playing basketball and football in the street.

I stopped a couple of times to speak to parents with little kids, hand out sheriff stickers and talk about the neighborhood.

All the river access points and schools were problem free.

### Sunday 8 a.m.-4 p.m., Sept. 18

I patrolled the neighborhood and completed all 28 listed vacation watch checks. All homes were secure.

It rained intermittently, but not hard. It was enough to keep the stop-sign-running bikeriders home. Every cyclist I saw managed to stop at stop signs.

It was a quiet and cool day.

## Monday 8 a.m. to 4 p.m., Sept. 19

I patrolled the neighborhood and completed all 26 listed vacation watch checks. All homes were secure.

I responded to an alarm in the 1000 block of Tennyson Way. The home appeared secure.

I was dispatched to an incomplete 911 call from Rio Americano High School. In the call, an adult male could be heard telling students to get back in line. Several calls back to the phone number were unsuccessful, so I contacted San Juan Safe Schools Dispatch and they contacted school administrators. The call appeared to have been an accidental dial.

#### Friday 8 a.m.-4 p.m., Sept. 23

I patrolled the neighborhood and completed all 29 listed vacation watch checks. All homes were secure.

I received an email from a resident stating that the driver of a newer white BMW appeared to be filming kids on his cell phone. I could not locate the vehicle.

I responded to an alarm in the 5100 block of Copperfield Way. The resident was home and the alarm may have been a malfunction.

I issued a warning to a driver at the intersection of American River Drive and Wilhaggin Drive. I monitored traffic around the area schools, but observed no major traffic issues.

I responded to a report about a man taking a bicycle at the intersection of North River Way and Ashton Drive. The complainant had left the area prior to my arrival. I contacted her by phone and advised her of her options.

I responded to a report of a loud party on Jardin Lane. It was a birthday party and they quieted down per my request.

#### IN AN EMERGENCY

- CALL 911 from a land line.
- Or, if calling from a cell phone within Sacramento County, call (916) 874-5111.

#### TO REPORT A CRIME

There are two ways to report a crime to the Sacramento County Sheriff's Department:

- 1. Call the Sheriff's Department NON-EMERGENCY LINE at (916) 874-5115. To bypass the recorded messaging when you call, dial 0 after the line is answered.
