

I check the river access points, but observed no problems.

I conducted parking enforcement near the Jesuit High School sports fields on American River Drive. All vehicles obeyed the parking rules.

I spoke to a resident at length about transient issues at his nearby business and offered him some remedies.

# Thursday 8 a.m.-4 p.m., Sept. 14

I patrolled the neighborhood and completed all 32 listed vacation watch checks. All homes were secure.

I drove by the schools, but observed no parking or vehicle code violations.

I assisted patrol with an audible alarm at a home on Saverien Drive. The residence was secure.

I was waved down by a resident concerned that her son is being harassed by teen-age high school students while he rides his bike home from school. She said her son usually sees them around 2:30 p.m. They drive by in a black Honda and yell at him and honk the horn. I advised her to report the issue to the school and I alerted other deputies to the issue.

The rest of the shift was quiet.

# Friday-Saturday, 4-11 p.m., Sept. 15

I patrolled the neighborhood and completed all 37 listed vacation watch checks. All homes were secure.

I checked the schools and parks. I cleared out Ashton Park after initiating a traffic stop in front of the park. It appeared that teens had gathered there following the Rio/Capital Christian football game. They were respectful and I did not observe any under-age drinking.

I monitored traffic at a number of stop signs and gave a verbal warning to one driver.

I responded to an email about a man sleeping in a car on Robin Lane. I contacted the man and determined that his vehicle was registered and legally parked in front of his mother's house. He said he was staying with her, but was sleeping in the car because he has a cat and his mother is allergic. Because he said he was homeless, I offered him resources and contact with our homeless outreach team. He declined. I reported the situation to the reporting neighbor and explained that the man was not breaking any laws.

I received an email regarding a package theft on Kevington Court.

# Saturday, 4-10 p.m., Sept. 16

I patrolled the neighborhood and completed all 33 listed vacation watch checks. All homes were secure.

All the river access areas checked clear. It was a quiet shift.

# Sunday 8 a.m.-4 p.m., Sept. 17

I patrolled the neighborhood and completed all 40 listed vacation watch checks. All homes were secure.

I stopped a driver for speeding on American River Drive and issued a verbal warning.

All river access points checked clear.

Ashton Park and Del Dayo School were very active with sports activities.

I responded to an email about shrubs blocking a sidewalk on American River Drive between Kingsford and Los Rios.

# Monday 8 a.m. to 4 p.m., Sept. 18

I patrolled the neighborhood and completed all 33 listed vacation watch checks. All homes were secure.

I patrolled the streets around Del Dayo Elementary, Rio Americano High School and Jesuit High School, but observed no traffic violations.

All parks and river access points checked clear of any problems.

# Tuesday 8 a.m. to 4 p.m., Sept. 19

I patrolled the neighborhood and completed all 29 listed vacation watch checks. All homes were secure.

I responded to a report of a suspicious person on Del Dayo Drive. A man was seen going up to doors then sitting out front. I located the man, who explained that he is working for a construction company passing out flyers. His company ID and driver's license checked clear. I advised him that it would be best for him to find another neighborhood to cover in order to avoid additional calls. He agreed and moved on.

I was waved down on Laverstock Way at Ashton Drive by a man who reported that someone has knocked on his door numerous times around 10:30 p.m. and then left. He said he is planning to install a security camera to identify the man. I said I would pass the information along to evening shift deputies.

I monitored traffic at Saverien and Ashton Drive and along Crondall, but observed no violations.

# Tuesday-Wednesday 8 p.m.-4 a.m., Sept. 19-20

I patrolled the neighborhood and completed all 30 listed vacation watch checks. All homes were secure.

I thought I saw a suspicious person wearing a backpack jiggling door handles at Del Dayo Elementary School, so I stopped to investigate. I determined that it was a part-time janitor whom I did not recognize because he is new on the job.

At 2 a.m. I stopped a bicyclist at Saverien Drive because he seemed lost out and out of place. He checked clear and I sent him on his way. He rode off toward Fair Oaks Boulevard and Watt Avenue out of the neighborhood.

# Wednesday 8 a.m.-4 p.m., Sept. 20

I patrolled the neighborhood and completed all 33 listed vacation watch checks. All homes were secure.

A resident complained about the multitude of vehicles parked near a home on Shelato Way. I drove by and saw six cars that appeared to be related to the residence. All were currently registered. I contacted the occupant of the home. She said all the cars were hers and they were legally parked. I told her that her neighbors had complained about the cars, but she did not appear interested.

I responded to a report of an elderly woman found in the 4800 block of American River Drive. The 85-year-old woman had walked away from her home, but had forgotten where she lived. She had no identification with her, but she knew her name. So, I ran the name through DMV and located her home in the 4600 block of Chancery Way. I took her to her adult son, who had been looking for her.

#### Wednesday 4-10 p.m., Sept. 20

I patrolled the neighborhood and completed all 31 listed vacation watch checks. All homes were secure.

I monitored traffic at Wilhaggin and American River Drive, Kingsford and Arden Way, and American River Drive and Jacob. I stopped one driver for failing to observe a stop sign and issued a verbal warning.

I monitored activity around Rio Americano High School, Del Dayo Elementary School and Ashton Park for some high-visibility security.

I checked the river access points and all were clear of problems.

I did parking enforcement near the Jesuit High School sports fields on American River Drive.

#### Thursday 8 a.m.-4 p.m., Sept. 21

I patrolled the neighborhood and completed all 33 listed vacation watch checks. All homes were secure.

I drove by the schools, but observed no traffic or parking violations.

I stopped a vehicle that failed to come to a complete stop at American River Drive and Harrington. The driver was unlicensed, was heading to school and claimed to have a learner's permit but did not have it with him. I cited him and impounded his vehicle.

I issued verbal warnings to other drivers for failing to come to a full stop at a stop sign. The locations were at American River Drive and Harrington; and on Jacob and Wycombe.

The rest of the shift was quiet.

#### Sunday 8 a.m.-4 p.m., Sept. 24

I patrolled the neighborhood and completed all 35 listed vacation watch checks. All homes were secure.

I monitored traffic at several intersections, but observed no violations.

I assisted patrol with a pursuit and crash involving two subjects, including one suspected of being armed with a gun. The subjects were arrested.

I responded to a report of an injured woman sitting on the side of the road. I was unable to locate her.

- Or, if calling from a cell phone within Sacramento County, call (916) 874-5111.

# **TO REPORT A CRIME**

There are two ways to report a crime to the Sacramento County Sheriff's Department:

- 1. Call the Sheriff's Department NON-EMERGENCY LINE at (916) 874-5115. To bypass the recorded messaging when you call, dial 0 after the line is answered.
